Council a representation, bearing date the twentyeighth day of July in the year one thousand eight hundred and eighty-one in the words following, that is to say :-

""We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fiftyninth years of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; of the Act of the third and fourth years of your Majesty chapter sixty and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Paul situate within the limits of the new parish of Swindon New Town in the county of Wilts and in the diocese of Gloucester and Bristol.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Paul situate within the limits of the new parish of Swindon New Town as aforesaid.

"Now therefore, with the consent of the Right Reverend Charles John Bishop of the said diocese of Gloucester and Bristol (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said new parish of Swindon New Town which is described in the schedule héreunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Paul situate within the limits of the new parish of Swindon New Town as aforesaid, and that the same should be named 'The District Chapelry of Saint Paul New Swindon."

"And with the like consent of the said Charles John Bishop of the said diocese of Gloucester and Bristol (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Paul situate within the limits of the new parish of Swindon New Town as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being : Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration and to make such Order with respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

## "The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Paul New Swindon being :-

"All that part of the new parish of Swindon New Town in the county of Wilts and in the diocese of Gloucester and Bristol which is bounded upon the north and upon the west by an imaginary line commencing upon the boundary which divides

the parish of Swindon in the said county and diocese at a point in the centre of the bridge which carries the high-road from Swindon to Cricklade over the Wilts and Berks Canal and extending thence first westward and then southwestward along the middle of the said canal for a distance of about one mile to the centre of Cambria Bridge which carries Cambria Bridge-road over the same canal and extending thence southeastward along the middle of the last-named road for a distance of eight chains or thereabouts to its junction with Radnor-street, and extending thence south-westward along the middle of the last-named street for a distance of eight chains or thereabouts to a point opposite to the north-western end of the wall or fence forming the north-eastern boundary of the Swindon Cemetery and extending thence alternately south-eastward and north-eastward to and along the said wall or fence for a distance of twenty chains or there-abouts to the entrance gates of the said cemetery at the western end of Dixon-street and extending thence southward across the western end of the last-named street to the northern end of the wall or fence forming the eastern boundary of the same cemetery and extending thence southward along the last-described wall or fence for a distance of four and a half chains or thereabouts (thereby passing the western end of Stafford-street), to the entrance to the said cemetery at the western end of the bridle-road or footway leading to the western end of Lansdown-road and extending thence first eastward and then southward along the middle of the said bridle-road or footway for a distance of fourteen chains or thereabouts to the boundary which divides the said new parish of Swindon New Town from the parish of Swindon aforesaid All which said part of the new parish of Swindon New Town aforesaid is bounded upon the remaining sides other than the north and the west that is to say upon the south and upon the east by the parish of Swindon aforesaid.'

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the respective Registrars of the said diocese of Gloucester and Bristol in the Registries at Gloucester and Bristol respectively.
