(PORT OF HARTLEPOOL.)

A T the Council Chamber, Whitehall, the 21st day of September, 1881.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do hereby define the following part of the Port of Hartlepool, in the county of Durham, as a

foreign animals wharf:

All that space and premises at the West Hartlepool Docks, in the county of Durham, situate on the south side of the North Basin, bounded by a line commencing at the south quay wall of the said North Basin at a point two hundred and seventy-two feet from the south-east corner thereof, and extending southward for a distance of sixty feet, thence eastward for a distance of fifty-three feet, thence southward for a distance of three hundred and ten feet, thence eastward for a distance of forty-five feet, thence southward for a distance of fifty-one feet six inches, thence westward for a distance of thirty-three feet, thence southward for a distance of twelve feet, thence westward for a distance of one hundred and sixtynine feet, thence northward for a distance of eighty-five feet, thence eastward for a distance of twenty feet, thence northward for a distance of three hundred and ten feet, thence eastward for a distance of fifty-three feet, thence northward for a distance of sixty feet to the beforenamed south quay wall of the said North Basin, thence eastward for a distance of twenty-four feet along the edge of the said south quay wall to the point aforesaid, all which space and premises are coloured pink on the plan of part of the Port of Hartlepool, deposited for the purposes of this Order at the Privy Council Office, a copy of which is deposited at the office of the Clerk of the Peace for the county of Durham.

1. This Order shall take effect from and immediately after the twenty-third day of September, one thousand eight hundred and eighty-one.

2. The limits of the following place which is declared by order of the Local Authority for the county of Hertford, dated the twenty-second day of August, one thousand eight hundred and eighty-one, to be a place infected with foot-and-mouth disease (namely),—the Field known as Studham Common Field, at Studham, in the county of Hertford, in the occupation of F. W. Partridge,—are hereby extended so as to include the place described in the Schedule to this Order, and the place described in the Schedule to this Order is hereby declared to be a place infected with foot-and-mouth disease.

1. This Order shall take effect from and immediately after the twenty-third day of September, one thousand eight hundred and eighty-one.

2. The following area (namely),—an area situate partly in the parish of Pewsey, in the county of Wilts, and partly in the parish of Manningford Abbotts, in the said county, bounded as follows:—In part on or towards the north by a line drawn in a westerly direction from the Hill Farm buildings and yards situate in the parish of Manningford Abbotts aforesaid in the occupation of Mr. John Brown, (such buildings and yards being included in the said area,) to the extreme point of Pewsey Manor Farm on the track from Manningford Abbotts aforesaid to Everley in the said county, commonly called Parson's Track, and in other part on or towards the north in an easterly
