Vessels and passengers arriving from any Mediterranean port in Egypt are to undergo a quarantine of 24 hours, after which a medical examination will be made, and should any sickness of an unusual type be discovered amongst the passengers, such passengers will be sent to Beyrout to undergo full quarantine. Vessels from the Red Sea which have not undergone quarantine in Egypt will be sent to Beyrout to undergo it, and those which have undergone quarantine in Egypt will be subjected to a second term at Beyrout.
