ORDER of the Local Government Board; Altering Name of Local Board of Health; Public Health Act, 1875, sec. 311:—

South Stoneham Union.

Local Government District of Shirley.

To the Shirley Local Board of Health, being the Sanitary Authority for the Urban Sanitary District of Shirley, in the county of Southampton;—

And to all others whom it may concern.

WHEREAS by Section 311 of The Public Health Act, 1875, it is enacted as follows:—

“Any Local Board constituted either before or after the passing of this Act may, with the sanction of the Local Government Board, change their name. Every such change of name shall be published in such manner as the Local Government Board may direct;”

And whereas the Local Board of Health for the said district of Shirley, at a Meeting held, after due notice, on the 7th day of December, 1881, resolved that the name of the said Board should be altered from Shirley Local Board of Health to Shirley and Freemantle Local Board of Health; and application has been made by them to the Local Government Board to sanction such change of name:

Now, therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby give our sanction to the name of the said Local Board of Health being changed to the “Shirley and Freemantle Local Board of Health.”

And We hereby direct that the said Shirley and Freemantle Local Board of Health shall cause this Instrument to be published two successive weeks in some newspaper circulating within their district, within one calendar month from the date hereof.
