An area comprising so much of the parish of Bromsgrove, in the county of Worcester, as lies within the following boundaries, that is to say, the main-road from Bromsgrove to Birmingham from opposite the Spring Pools Chadwich to the Plough Inn, Whetty, from thence along Callow Brook-lane to the Gannow Green, from thence by Chapmans Hill-lane into the Bromsgrove and Halesowen-road, from thence by the Malt House-lane to Chadwich, and from thence by a water-course through Spring Pools to the Birmingham-road at the point first-mentioned.
