much of the lands in the county of Northampton as lie within the following boundaries, that is to say, the London and North-Western railway on the east and south, and so much of the lands in the counties of Leicester and Northampton as lie within the following boundaries, that is to say, the road leading from the point where the railway line crosses the Welham-road through Welham to the point at which the bridle-road enters the road from Welham to Slawston on the west.

(29.) So much of the parish of Merevale, in the county of Leicester, as lies within the following boundaries, that is to say, on the north by The Green Lanes, on the south and east by the brook which adjoins Beenhills farm, and on the west by the brook which separates the counties of Leicester and Warwick.

(30.) So much of the parishes of Overseal, Gresley, and Ashby-de-la-Zouch, in the counties of Leicester and Derby, as lies within the following boundaries, that is to say, turf and arable land in the occupation of Mr. Mason and also an Occupation-road in the parish of Gresley, in the county of Derby, on the north, turf and arable land in the occupation of Mr. Whitehead on the south, turf and arable land in the occupation of Messrs. Adams and Winterton, and the Bosworth and Burton-upon-Trent turnpike-road on the west, and grass land in the occupation of Mr. Clamp, in the parish of Ashby-de-la-Zouch, on the cast.

(31.) The whole of the parish of Theddingworth, and so much of the parish of Lubenham as is included within the following boundaries, that is to say, on the north the extreme boundary of Theddingworth parish, on the south the road from Lubenham to Theddingworth, on the east the road from Lubenham to Laughton, and on the west the road from Theddingworth to Laughton, in the county of Leicester.

- (32.) So much of the parish of Stonton Wyville, in the county of Leicester, as lies within the following boundaries, that is to say, Stonton brook on the north and west, the road from Tur Langton to Glooston on the south, and the boundary of the parish of Glooston on the east.
- (33.) So much of the parish of Smeeton, in the county of Leicester, as lies within the following boundaries, that i to say, the read from Kibworth to Smeeton—the north, the road from Gumley to Debda e on the south, the turnpike-road from Debdale to Kibworth on the east, and the road from Gumley to Smeeton on the west.
- (34.) So much of the parishes of East Norton, Loddington, and Tugby, in the county of Leicester, as lies within the following boundaries, that is to say, the London and North-Western railway on the north, Uppingham tumpikeroad on the south, Loddington-road on the east, and Tugby Wood-lane on the west.

Lincolnshire (Holland).—So much of the parishes of Frieston, and Fishtoft, in the petty sessional division of the Hundreds of Kirton and Skirbeck, in the Paris of Holland, Lincolnshire, as lies within the following boundaries, that is to say, the Roman Bank or Old Sca Bank on the scuth, and west from George Fletcher's house to Hobhole Sluice, on the north by Hobhole Drain from Hobhole Sluice to Fishtoft Bridge near the Rectory, and on the east by Frieston Scrane End-road from Fishtoft Bridge to George Fletcher's house aforesaid, but exclusive of the Frieston Scrane End-road.

Lincolnshire (Lindsey).—So much of the parish of Roxby, in the Paris of Lindsey, Lincolnshire, as lies within the following boundaries, that is to say, the hedge dividing the parishes of Roxby and Winterton on the north, the lands lying on the south side of and adjoining the road leading out of the Brigg-road to Roxby on the south, the Brigg-road on the east, and the close of land known as the Coatlawn in the occupation of Thomas Barrett on the west.

Northamptonshire.—(1.) So much of the parishes of Little Bowden, and Braybrooke, in the county of Northampton, as lies within the following boundaries, that is to say, the Bottom, Top, and Little Darnells, Middle field, and three ploughed fields, in the occupation of William Payne Cowley, Braybrooke; The Slip, first and second Hill, two meadows, one ploughed field, and Crowthorns, all in the parish of Little Bowden, and five fields in the parish of Braybrooke, all in the occupation of William West, Little Bowden; three fields in the occupation of Mr. Broughton, in the parish of Braybrooke; Clack Hill field in the occupation of Sir W. de Capell Brooke, Bart., in the parish of Little Bowden, and Monks two fields also in the parish of Little Bowden.

- (2.) So much of the parish of Weston-by-Welland, in the county of Northampton, as lies within the following boundaries, that is to say, Wade's two fields, and Hayer's field on the east, the river Welland and the London and North-Western Railway bank on the north, Smith's field and Slawston-road on the west, and Row latt's field and Ashley-road on the south.
- (3.) The parish of Abington, in the county of Northampton.
- (4.) So much of the parish of Braybrooke, in the county of Northampton, as lies within the following boundaries, that is to say, the road leading from Braybrooke to Desborough on the south for half a mile, the turnpike-road from Harborough to Desborough half a mile each side of the Commons Lodge on the north, the road leading from Braybrooke to Market Harborough on the west, and the extreme boundary of Jonathan Chater's farm on the east.
- (5.) So much of the parish of Great Bowden, in the county of Leicester, and of the parish of Little Bowden, in the county of Northampton, as lies within the following boundaries, that is to say, the extreme boundary of John Watson's farm, William Gatty's farm, Sir W. de Capell Brooke's Bridge field, Barber's meadow, Messrs. Bird and Teblett's fields, the Barn fields, and J. Brown's meadow, all in the parish of Little Bowden, on the south-east, Mr. Fisher's farm, Great Bowden, on the north-east, Clark's and Patrick's fields on the north-west, and the boundary of Market parish on the south-west.

(6.) So much of the parish of Braybrooke, in the county of Northampton, as lies within the following boundaries, that is to say, certain fields in the occupation of Messrs. Parker, Cowley, Kilhorn, Soak, King, and Battams.

(7.) So much of the parishes of Kilworth, and South Kilworth, in the county of Leicester, and of the parishes of Stanford, and Welford, in the county of Northampton, as lies within the following boundaries, that is to say, certain fields in the occupation of Messrs. Wood and George Gee in the parish of Kilworth, Wood in the parish of Stanford, and Wood, W. Gardiner, Haynes, and John Butlin in the
