The QUEEN's Most Excellent Majesty in Council. W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter sixty; of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the eleventh and twelfth years of Her Majesty, chapter thirty-seven, and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the fifteenth day of December, in the year one thousand eight hundred and eighty-one, in the words following, that is to say:-

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the third and fourth years of your Majesty chapter sixty of the Act of the eighth and ninth years of your Majesty chapter seventy and of the Act of the eleventh and twelfth years of your Majesty chapter thirty-seven and of the Act of the nineteenth and twentieth years of your Majesty chapter fifty-five have prepared and now humbly lay before your Majesty in Council the following representation for altering the boundaries of the district chapelry of Saint George the Martyr Daubhill within the original limits of the parish of Deane in the county of Lancaster and in the diocese of Manchester.

"Whereas by the authority of an Order of your Majesty in Council bearing date the second day of March in the year one thousand eight hundred and eighty-one and published in the London Gazette on the fourth day of the same month in the same year a part of the parish of Deane in the county and diocese aforesaid was assigned as a district chapelry to the consecrated church of Saint George the Martyr situate at Daubhill in the same parish and such district chapelry was named 'The District Chapelry of Saint George the Martyr Daubhill.

"And whereas it has been proposed to us and it appears to us to be expedient that the bounduries of the said district chapelry of Saint George the Martyr Daubhill should be altered so as to include within its limits a portion of the new parish of Emmanuel Bolton-le-Moors, within the original limits of the parish of Bolton-le-Moors in the said county of Lancaster and in the said diocese of Manchester.

"Now therefore with the consent of the Right Reverend James Bishop of the said diocese of Manchester as such Bishop and also as the patron in right of his See of the vicarage of the said parish of Bolton-le-Moors with the consent of the Reverend Henry Powell Clerk in Holy Orders, as the vicar or incumbent of the said vicarage of the parish of Bolton-lc-Moors aforesaid and also as the patron (in right of his incumbency of the aforesaid vicarage) of the vicarage of the said new parish of Emmanuel, Bolton-le-Moors, with the consent of the Reverend Robert Culpepper Weston, Clerk in Holy Orders as the vicar or incumbent of the said vicarage of the new parish of Emmanuel Bolton-le-Moors aforesaid, with the consent of the Reverend William Carus, Canon Residentiary of the Cathedral Church of the Holy Trinity in the city of Winchester Clerk in Holy Orders, of the Reverend Edmund Hollond of Benhall Lodge Saxmundham in the county of Suffolk, and of Hyde Park-gardens in the county of Middlesex Clerk in Holy Orders, of the Reverend William Cadman, rector or incumbent of the rectory of the district parish of Trinity Saint Marylebone in the said county of Middlesex Clerk in Holy Orders, of the Reverend George Edward Tate vicar or incumbent of the vicarage of the new parish of Saint Mary Kippington in the county of Kent Clerk in Holy Orders, and of the Reverend Field Flowers Goe, rector or incumbent of the rectory of the parish of Saint George Bloomsbury in the said county of Middlesex Clerk in Holy Orders, as the patrons of the vicarage of the said parish of Deane with the consent of the Reverend Henry Sheridan Patterson Clerk in Holy Orders as the vicar or incumbent of the said vicarage of the parish of Deane aforesaid and also as one of the patrons of the perpetual curacy of the said district chapelry of Saint George the Martyr Daubhill, with the
