"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or to any of them in accordance with the provisions of the herein named Acts or of either of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Clement Greenheys, being:-

"All those several contiguous portions of the new parish of Christ Church Moss Side of the new parish of Saint Margaret Whalley Range of the new parish of Saint Mary, Hulme, and of the new parish of Saint Paul Hulme all within the original limits of the parish of Manchester in the county of Lancaster and in the diocese of Manchester which said portions of such new parishes are com-prised within and are bounded by an imaginary line commencing upon the boundary which divides the new parish of Saint John Hulme within the original limits of the said parish of Manchester from the new parish of Christ Church Moss Side aforesaid at the point where Burlington-street, Union-street and Greenheys-lane all meet and extending thence first southward and then southwestward along the middle of the said Greenheyslane for a distance of seventeen chains or thereabouts to its junction with Carlton-street and extending thence southward along the middle of the last-named street for a distance of seven chains or thereabouts to its junction with Derby-street and continuing thence still southward across the last-named street and along the middle of that part of the said Carlton-street which is not yet open for public traffic for a further distance of seven chains or thereabouts to a point in the middle of Moss-lane East upon the boundary which divides the said new parish of Christ Church Moss Side from the new parish of Saint Margaret Whalley Range aforesaid, and extending thence northwestward along the middle of the last-named lane for a distance of thirty-three chains or thereabouts (thereby following for the first part the last described boundary) to the junction of the same lane with Moss-lane West and with Embden-street and extending thence north-eastward along the middle of the last-named street for a distance of thirtythree yards or thereabouts thereby crossing at the south-western end of Embden-street aforesaid the boundary which divides the said new parish of Saint Margaret Whalley Rauge from the new parish of Saint Mary Hulme aforesaid to the point where the same boundary again crosses the middle of the said Embden-street, and extending thence first northward along the said boundary for a distance of twenty-two yards or thereabouts to a point in the middle of Saint Mary's-street and then eastward along the same boundary for a distance of seventeen yards or thereabouts to the point where the same boundary again crosses the middle of Embden-street aforesaid near to its junction with Lingard-street and extending thence north-eastward along the middle of the said Embdenstreet for a distance of eighteen and a half chains or thereabouts thereby crossing the boundary which divides the said new parish of Saint Mary Hulme from the new parish of Saint Paul Hulme aforesaid to a point near to the junction of the said Embden-street with Greenhill-street upon the boundary which divides the said new parish of Saint Paul Hulme from the new parish of Christ Church Moss Side aforesaid and continuing thence first northward and then north-eastward along the last mentioned boundary for a distance of two and a

half chains or thereabouts thereby passing a little to the north-west of Embden-street aforesaid to the point in the middle of Chapman-street where the said last mentioned boundary joins the boundary which divides the said new parish of Chrish Church Moss Side from the new parish of the Holy Trinity Hulme within the original limits of the parish of Manchester aforesaid and continuing thence still north-eastward along the last mentioned boundary for a distance of five chains or thereabouts to a point at the junction of Embden-street aforesaid with Craven-street where the said last-mentioned boundary joins the boundary dividing the said new parish of Christ Church Moss Side from the new parish of Saint John Hulme aforesaid and extending thence first south-eastward and then eastward along the last-mentioned boundary for a distance of nineteen chains or thereabouts thereby following the course of Craven-street aforesaid and of Unionstreet aforesaid to the first-described point where the last-named street joins Burlington-street and Greenheys-lane as aforesaid at which point the said imaginary line commenced."

And whereas drafts of the said scheme have in accordance with the provisions of the herein-before firstly-mentioned Act been transmitted to the patrons and to the incumbents of the several cures out of which it is intended that the district recommended in such scheme to be constituted shall be taken, and such patrons and incumbents have respectively signified their assent to such scheme.

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts: and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the registrar of the said diocese of Manchester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; of the Act of the eleventh and twelfth years of Her Majesty, chapter thirty-seven; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-third day of February, in the year one thousand eight hundred and eighty-two, in the words following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty chapter forty-nine; of the Act of the eleventh and twelfth years of your Majesty, chapter thirty-seven; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, have prepared, and now humbly lay before your Majesty in Council, the following representation
