

consolidated chapelry to the consecrated church of All Saints situate in the district chapelry of Saint Saviour, Eastbourne, within the original limits of the parish of Eastbourne in the county of Sussex and in the diocese of Chichester.

"Whereas at certain extremities of the said district chapelry of Saint Saviour, Eastbourne, of the consolidated chapelry of Saint John, Meads, within the original limits of the said parish of Eastbourne, and of the chapelry district of the Holy Trinity, Eastbourne, also within the original limits of the same parish which said extremities lie contiguous one to another and are described in the schedule hereunder written there is collected together a population which is situate at a distance from the several churches of such district chapelry, consolidated chapelry, and chapelry district respectively.

"And whereas it appears to us to be expedient that such contiguous portions of the said district chapelry of Saint Saviour, Eastbourne, of the said consolidated chapelry of Saint John, Meads, and of the said chapelry district of the Holy Trinity, Eastbourne, should be formed into a consolidated chapelry for all ecclesiastical purposes and that the same should be assigned to the said church of All Saints, situate in the district chapelry of Saint Saviour, Eastbourne, as aforesaid.

"Now, therefore, with the consent of the Right Reverend Richard Bishop of the said diocese of Chichester as such Bishop with the consent of the Reverend Henry Robert Whelpton, Clerk in Holy Orders, now incumbent of the perpetual curacy of the said district chapelry of Saint Saviour, Eastbourne, who is also the patron of the same perpetual curacy, with the consent of the Reverend Thomas Pitman, Clerk in Holy Orders, now vicar or incumbent of the vicarage of the said parish of Eastbourne, of John Swift, of Southfields, Eastbourne, aforesaid, Esquire, of Walter James Hood, of Osborne House, Eastbourne aforesaid, Esquire, of the Reverend William Cadman, Clerk in Holy Orders, now rector or incumbent of the rectory of the district parish of Trinity, Saint Marylebone, in the county of Middlesex, and of the Reverend John Richardson, Clerk in Holy Orders, now vicar or incumbent of the vicarage of the new parish of Camden, in the county of Surrey, the patrons of the perpetual curacy of the said consolidated chapelry of Saint John, Meads, and with the consent of the said Thomas Pitman as the patron, in right of his incumbency of the said vicarage of the parish of Eastbourne, of the perpetual curacy of the said chapelry district of the Holy Trinity, Eastbourne (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we the said Ecclesiastical Commissioners for England humbly represent that it would, in our opinion, be expedient that all those contiguous portions of the said district chapelry of Saint Saviour, Eastbourne, of the said consolidated chapelry of Saint John, Meads, and of the said chapelry district of the Holy Trinity, Eastbourne, which are described in the schedule hereunder written, all which portions together with the boundaries thereof are delineated and set forth on the map or plan hereunto annexed should be united and formed into one consolidated chapelry for the said church of All Saints situate in the district chapelry of Saint Saviour, Eastbourne, aforesaid, and that the same should be named 'The Consolidated Chapelry of All Saints, Eastbourne.'

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration and to make such Order in respect thereto as to your Majesty in your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of All Saints, Eastbourne, being :—

"All that portion of the district chapelry of Saint Saviour, Eastbourne, within the original limits of the parish of Eastbourne in the county of Sussex and in the diocese of Chichester which is bounded on the west by the consolidated chapelry of Saint John, Meads, also within the original limits of the parish of Eastbourne aforesaid on the south-east by the sea on the north-east and on the east by the chapelry district of the Holy Trinity, Eastbourne, also within the original limits of the said parish of Eastbourne and upon the remaining side that is to say on the north by an imaginary line commencing upon the boundary which divides the said chapelry district of the Holy Trinity, Eastbourne, from the district chapelry of Saint Saviour, Eastbourne, aforesaid, at the point where the road which passes in front of the houses called or known respectively as Chiswick-place and as Cornfield-terrace is joined by Blackwater-road and extending thence westward along the middle of the last-named road for a distance of twenty-five chains or thereabouts to the boundary at the intersection of the same road by Grange-road which boundary divides the said district chapelry of Saint Saviour, Eastbourne, from the consolidated chapelry of Saint John, Meads, aforesaid.

"And also all that portion of the said consolidated chapelry of Saint John, Meads, which is contiguous to and is situate on the western side of the hereinbefore described portion of the said district chapelry of Saint Saviour, Eastbourne, which said portion of the consolidated chapelry of Saint John, Meads, aforesaid is bounded on the east by the said district chapelry of Saint Saviour, Eastbourne, and upon all other sides that is to say on the north on the west and on the south by an imaginary line commencing upon the boundary which divides the hereinbefore mentioned portion of the said district chapelry of Saint Saviour, Eastbourne, from the consolidated chapelry of Saint John, Meads, aforesaid, at the said point where Grange-road is intersected by Blackwater-road aforesaid and extending thence westward along the middle of the last-named road for a distance of twelve and a half chains or thereabouts to its intersection by Granville-road and extending thence southward along the middle of the last-named road for a distance of twenty chains or thereabouts to its junction with Silverdale-road and extending thence eastward along the middle of the last-named road for a distance of thirteen and a half chains or thereabouts to the boundary at the point where the said last-named road is joined by Grange-road aforesaid which boundary divides the said consolidated chapelry of Saint John, Meads, from the district chapelry of Saint Saviour, Eastbourne, aforesaid.

"And also all that portion of the chapelry district of the Holy Trinity, Eastbourne aforesaid which is contiguous to and is situate on the eastern side of the hereinbefore described portion of the district chapelry of Saint Saviour, Eastbourne, aforesaid, which said portion of the chapelry district of the Holy Trinity, Eastbourne, aforesaid, is bounded on the south-east by the sea aforesaid on the south-west and on the west by the district chapelry of Saint Saviour, Eastbourne, aforesaid and upon the remaining side, that is to say on the north-east by an imaginary line commencing upon the boundary which divides the said district chapelry of Saint Saviour, Eastbourne, from the chapelry district of the Holy
