By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. This Order shall take effect from and immediately after the thirteenth day of May, one thou-

sand eight hundred and eighty-two.

2. The following areas (namely),—(1.) so much of the parish of Ilfracombe, in the county of Devon, as lies within the following boundaries, that is to say, a stream of water opposite Wigmouth farm on the west, the south fence of the new Ilfracombe and Combmartin-road and the south fence of Watermouth-park on the north, the east fence of the Home meadow and Horse park on the east, and the south fence of Lydford farm on the south, and (2.) the parishes of Buckland Monachorum, Meavy, and Walkhampton, in the county of Devon,—which were declared by Orders of Council dated respectively the seventh and sixteenth days of March, one thousand eight hundred and eighty-two, to be areas infected with foot-and-mouth disease, are hereby declared to be free from foot-and-mouth disease, and those areas shall, as from the commencement of this Order, cease to be areas infected with foot-andmouth disease. 1. This Order shall take effect from and immediately after the thirteenth day of May, one thou-

sand eight hundred and eighty-two.

2. The following area (namely),—so much of the parish of Monks Kirby, in the county of Warwick, as lies within the following boundaries, that is to say, the turnpike-road from Lutterworth to Coventry on the north, the parish of Churchover on the south, and Muntilse-lane leading from the Lutterworth and Coventry turnpike-road to the parish of Harborough Magna on the west,
—which was declared by Order of Council dated the eighth day of April, one thousand eight hundred and eighty-two, to be an area infected with foot-and-mouth disease, is hereby declared to be free from foot-and-mouth disease, and that area shall, as from the commencement of this Order, cease to be an area infected with foot-andmouth disease. (2.) An area comprising so much of the parish of Longdon, in the county of Stafford, as lies on the north-eastern side of the turnpike-road from Lichfield to Rugeley, and on the south-eastern side of How brook.

1. This Order shall take effect from and immediately after the fourteenth day of May, one thou-

sand eight hundred and eighty-two.

2. The limits of the following area which is declared by Order of Council dated the fifth day of May, one thousand eight hundred and eighty-two, to be an area infected with foot-and-mouth disease (namely),—so much of the parish of Preston Baggott, in the county of Warwick, as lies on the north side of the road from Henley in Arden to Warwick, and so much of the parish of Rowington, in the said county, as is bounded on the east by the Birmingham and Stratford-on-Avon Canal,—are hereby extended so as to include the area described in the Schedule to this Order, and the area described in the Schedule to

this Order is hereby declared to be an area infected with foot-and-mouth disease.

An area comprising the whole of the parish of Preston Baggott, in the county of Warwick, including the road on the east of that parish leading from Claverdon-road to Yarnagle Common, and so much of the parish of Rowington, in the said county, as is bounded on the east by the Birmingham and Stratford-on-Avon Canal.

THE SCHLESWIG-HOLSTEIN ORDER OF 1882.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. This Order may be cited as The Schleswig-

Holstein Order of 1882.

2. This Order extends to England and Wales and Scotland only.

3. In this Order words have the same meaning

as in The Animals Order.

4. This Order shall take effect from and immediately after the first day of June, one thousand eight hundred and eighty-two, and shall cease to have effect from and immediately after the thirty-first day of December, one thousand eight hundred and eighty-two, without prejudice to the institution or prosecution of any proceeding in respect of an offence committed on or before that day.

5. Cattle brought from a port or place in either of the parts of the German Empire respectively known as Schleswig and as Holstein, (in this Order referred to as Schleswig-Holstein cattle,) and sheep and goats brought from Schleswig or Holstein in the same vessel with Schleswig-Holstein cattle, may be landed for slaughter in a foreign animals

wharf, but not elsewhere.

6. The landing of Schleswig-Holstein cattle in a foreign animals wharf shall be subject to the condition that they are accompanied by a declaration and certificates, such as are indicated in the forms in the Schedule to this Order, or to the like effect.

7. If the declaration accompanying any cattle imported under this Order is untrue in any particular, as regards any one of the cattle to which it relates, the master of the vessel shall be deemed guilty of an offence against The Contagious Diseases (Animals) Act, 1878, with respect to all the cattle to which the declaration relates, unless he shows to the satisfaction of the Justices before whom he is charged, that he did not know of the same being so untrue, and that he could not with reasonable diligence have obtained that C. L. Peel. knowledge.
