THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. Each of the areas described in the Schedule to this Order is hereby declared to be an area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the eighteenth day of May, one thousand eight hundred and eighty-two.

SCHEDULE.

(1.) An area at Quarrington, in the Parts of Kesteven, Lincolnshire, comprised within the following boundaries, that is to say, the highway leading from Sleaford to Grantham on the south, and towards the west to Quarrington Wash Dyke, thence on or towards the north by the Quarrington and Ranceby Beck to Lord Bristol's Top Plantation, and on or towards the north-east by certain fields in the occupation of Frederick Ward and Frederick Rippon to the said Frederick Rippon's farm buildings in the parish of Holdingham, and on or towards the south-east by Rippon's Cottages to William Clark Allen's Bouncing Hill farm, and on or towards the south by an imaginary line to the Sleaford Water Works Engine-house, the Sleaford Water Works Tank, and a certain field in the occupation of John Taylor Marston, to the highway first-mentioned.

(2.) An area comprising so much of the parish of Temple Bruer, in the Parts of Kesteven, Lincolnshire, as lies within the following boundaries, that is to say, the Cuckoo-lane south and towards the west to Birds Plantation, and on or towards the north by the boundary hedge between Robert G. F. Howard's, Atley Barnes, and John Chatterton's, Temple Grange, and on or towards the east by the Blind Bob field and the Garden Close to the Fox Hills Cover, and on or towards the south by the said Fox Hills Cover, and Long Close in the occupation of the said John Chatterton to the Cuckoo-lane aforesaid.

An area comprising so much of the township of Longnor, in the county of Stafford, as lies on the northern side of the road from Longnor Mill through Longnor village to Crowdecote.

1. This Order shall take effect from and immediately after the seventeenth day of May, one thousand eight hundred and eighty-two.

2. The limits of the following place which is declared by order of the Local Authority for the county of Berwick, dated the twenty-fourth day of April, one thousand eight hundred and eighty-two, to be a place infected with pleuro-pneumonia (namely),—the Home Steading, the Stables, and the Cow Park, at the Hirsell,—are hereby extended so as to include the place described in the Schedule to this Order, and the place described in the Schedule to this Order is hereby declared to be a place infected with pleuro-pneumonia.

SCHEDULE.

A place comprising the Home Steading, the Stables, and the Cow Park, at the Hirsell; the farm of Crooks, including Farm Steading and offices; and the farm of Fireburnmill, including Steading and offices; the property of the Right Honourable the Earl of Home, all in the parish of Coldstream, in the county of Berwick.

THE CONTAGIOUS DISEASES (ANIMALS) ACT, 1878.

THE following areas are now *Areas Infected with Foot-and-Mouth Disease* under the above-mentioned Act (except the lines of railway within those areas as far as those lines are used or required for the transit of animals through those areas, without untrucking):—

Berwickshire.—An area in the parishes of Edrom, Swinton, Whitsome, Dunse, and Fogo, in the county of Berwick, comprising Bellshiel farm, Kimmerghame Mains farm, Kimmerghame Mill farm, Harcarse farm, Harcarse Hill farm, Crowfootbank farm, Greenrig farm, Whitsome South Laws farm, Greenknowe farm, Middlestots farm, Kimmerghame Policies and Parks, Mount Pleasant farm, Mungoswalls farm, Wedderburn Policies and Parks, Cairnhill farm, Nisbet Hill farm, Nisbet Mill farm, Nisbet Policies and Parks, Bogend farm, together with all roads, public and private, bounding or intersecting the same.

Cardiganshire.—So much of the county of Cardigan as lies within the following boundaries, that is to say, from Neuadd-ddu Cross-roads on the north, along a bye-road running in a southerly direction to Bwlch-di-hewid on the west, thence along the highway in an easterly direction as far as Bwlch-y-Person, thence following the same highway in a north-easterly direction to the village of Ystrad, and from thence along the turnpike-road to Neuadd-ddu before-mentioned.

Cheshire.—(1.) So much of the township of Hellingworth, in the county of Cheshire, as lies within the following boundaries, that is to say, the Manchester and Saltersbrook turnpike-road, Green-lane, then the fence running to Widdow
