THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Consul at New Orleans, enclosing a copy of a notice issued by the Governor of Louisiana, declaring that Rio de Janeiro, Vera Cruz, Havana, Matanzas, St. Yago de Cuba, Port au Prince, in the Island of Jamaica, St. Pierre, in the Island of Martinique, or Point Pitre, in the Island of Guadeloupe, to be infected with yellow fever, and subjecting all vessels arriving on and after the 1st May from the above ports, or that have communicated at sea with vessels from those ports, to a quarantine of not less than three full days' duration.
