

hand and episcopal seal to this scheme) we the Ecclesiastical Commissioners for England humbly recommend and propose that upon and from the day on which any Order of your Majesty in Council ratifying this scheme shall be published in the London Gazette the said Archdeaconry of Durham shall be divided into two archdeaconries whereof one archdeaconry shall as heretofore be styled 'The Archdeaconry of Durham' and shall comprise and consist of those rural deaneries now portion of the said present Archdeaconry of Durham the names of which are set forth in the first schedule to this scheme annexed and that the other archdeaconry shall be styled 'The Archdeaconry of Auckland' and shall comprise and consist of those rural deaneries the names of which are set forth in the said second schedule to this scheme annexed which said last-mentioned rural deaneries together with the rural deaneries named in the said first schedule to this scheme annexed now constitute the present undivided Archdeaconry of Durham. And we the said Ecclesiastical Commissioners for England further recommend and propose that we be authorized to pay yearly and every year out of the common fund created by the said Act of the third and fourth years of your Majesty chapter one hundred and thirteen to the Archdeacon of the Archdeaconry of Auckland hereinbefore recommended and proposed to be created and to his successors in the same Archdeaconry the sum of two hundred pounds per annum such yearly payment to be made on the first day of January in every year in respect of the twelve calendar months ended that day. Provided always that the first payment so to be made by us as aforesaid shall be proportioned to the period which shall have elapsed between the date of the institution of the first Archdeacon of the said Archdeaconry of Auckland and the first day of January next following the date of such institution and that every such yearly payment as aforesaid shall be apportionable between the Archdeacon (or as the case may be) the representatives of an Archdeacon who has resigned or otherwise avoided the said Archdeaconry of Auckland on any other day than the first day of January in any year and the Archdeacon who shall next thereafter be instituted to the same Archdeaconry and that every such yearly payment shall be made by us only after we shall have been satisfied that the Archdeacon who applies (or whose representatives apply) for it has during the previous year complied with the conditions as to residence which at the date of such application are required by law.

"And we further recommend and propose that nothing herein contained shall prevent us from hereafter recommending and proposing any other matter or thing relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of Parliament."

"The Archdeaconry of Durham comprising and consisting of the following seven rural deaneries namely:—

1. The Rural Deanery of Jarrow.
2. The Rural Deanery of Chester-le-Street.
3. The Rural Deanery of Ryton.
4. The Rural Deanery of Durham.
5. The Rural Deanery of Houghton-le-Spring.
6. The Rural Deanery of Wearmouth.
7. The Rural Deanery of Easington.

"The SECOND SCHEDULE to which the foregoing Scheme has reference.

"The Archdeaconry of Auckland comprising and consisting of the following four rural deaneries namely:—

1. The Rural Deanery of Auckland.
2. The Rural Deanery of Stanhope.
3. The Rural Deanery of Darlington.
4. The Rural Deanery of Stockton."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Durham.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. This Order shall take effect from and immediately after the twentieth day of May, one thousand eight hundred and eighty-two.

2. The limits of the following area which is declared by Order of Council dated the eighth day of May, one thousand eight hundred and eighty-two, to be an area infected with foot-and-mouth disease (namely),—so much of the parishes and townships of Repton, and Foremark, in the county of Derby, as lies within the following boundaries, that is to say, from William Waytes house Milton along Milton-lane to a point opposite to Barnett's house at Brook End Repton, thence to the right up Monsholme-lane through Miss Measham's first Monsholme Meadow to Meakins Johny Meadow gate and fence to Old Trent Water, along the Old Trent to junction with main river, along the main river Trent by Twyford Ferry to junction with back water from Anchor Church, thence to the right along the back water, Anchor Church Pool, and brook course to John Goodall's Church Close at Foremark, turning to the left to Pale Close gate, and along the eastern and southern boundary fence of Church Close to the point where the fence intersects the foot-road from Foremark to Milton village, thence to the left along the foot-road to Milton village, turning to the right through a portion of the village to William Waytes house aforesaid,—are hereby extended so as to include the area described in the Schedule to this Order, and the area described in the Schedule to this Order is hereby declared to be an area infected with foot-and-mouth disease.

SCHEDULE.

An area comprising so much of the parishes or townships of Repton, and Foremark, in the county of Derby, as lies within the following boundaries, that is to say, from William Waytes
