

AT the Court at *Windsor*, the 17th day of *May*, 1882.

PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the seventh and eighth years of Her Majesty chapter ninety-four and of the Act of the thirty-second and thirty-third years of Her Majesty chapter ninety-four, duly prepared and laid before Her Majesty in Council a scheme or representation bearing date the fourth day of May, in the year one thousand eight hundred and eighty-two, in the words following, that is to say;—

“We the Ecclesiastical Commissioners for England acting under the provisions of the Act of the seventh and eighth years of your Majesty chapter ninety-four and of the Act of the thirty-second and thirty-third years of your Majesty chapter ninety-four have prepared and now humbly lay before your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Pemberton and of the district of Saint Andrew Wigan both in the county of Lancaster and in the diocese of Liverpool.

“Whereas by the authority of an Order of your Majesty in Council bearing date the first day of February in the year one thousand eight hundred and thirty-eight and published in the London Gazette on the third day of April in the same year a part of the parish of All Saints Wigan in the county of Lancaster aforesaid and at that time in the diocese of Chester was assigned as a district chapelry to the consecrated church situate within the limits of the township of Pemberton in the said parish and the same was called ‘The District of Pemberton.

“And whereas under the provisions of the Act of the nineteenth and twentieth years of your Majesty chapter one hundred and four, the said district chapelry of Pemberton subsequently became a new parish of the character contemplated by that Act and by the Act of the sixth and seventh years of your Majesty chapter thirty-seven and by the said above-mentioned Act of the thirty-second and thirty-third years of your Majesty chapter ninety-four.

“And whereas under the provisions of another Order of your Majesty in Council bearing date the twenty-fourth day of March in the year one thousand eight hundred and seventy-one and published in the London Gazette on the twenty-eighth day of the same month a portion of the said parish of All Saints Wigan together with a portion of the said new parish of Pemberton were constituted into a separate district and the same was named ‘The District of Saint Andrew Wigan.’

“And whereas it has been represented to us and it appears to us to be expedient that the portion of the said district of Saint Andrew Wigan which was taken from the said new parish of Pemberton should be dis severed from such district and should be re-annexed to the said new parish.

“Now therefore with the consent of the Right Reverend John Charles, Bishop of the said diocese of Liverpool (in testimony whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of your Majesty in Council ratifying this scheme or representation the boundaries of the said new parish of Pemberton and of the said district of Saint Andrew Wigan shall be altered so that the said new parish shall include

all that portion of the district of Saint Andrew Wigan aforesaid which is described in the schedule hereunder written and is delineated and set forth upon the map or plan hereunto appended and is thereon coloured pink and that from and after the same day and without any assurance in the law other than such duly gazetted Order the said portion of the district of Saint Andrew Wigan so to be dis severed therefrom shall be re-annexed to and shall again become and be and form part of the said new parish of Pemberton.

“And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or of either of them or of any other Act of Parliament.

“The SCHEDULE to which the foregoing Scheme or Representation has reference.

“The territory proposed to be dis severed from the district of Saint Andrew Wigan in the county of Lancaster and in the diocese of Liverpool and to be re-annexed to the new parish of Pemberton in the same county and diocese, being:—

“All that portion of the said district of Saint Andrew Wigan (comprising the village or hamlet of Marsh Green) which is situate within the limits of the township of Pemberton and which sometime formed a part of the new parish of Pemberton aforesaid.”

And whereas drafts of the said scheme or representation have been transmitted to the patrons and to the incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such patrons and incumbents have respectively signified their assent thereto.

And whereas the said scheme or representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme or representation and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Liverpool.

WHEREAS the Town Council of the borough of Arundel, in the county of Sussex, have presented a petition to Her Majesty in Council stating that an Order in Council has been made directing the discontinuance of burials in the churchyard of the parish of Arundel, and representing that for divers reasons it is extremely difficult to obtain ground within that parish or an adjoining parish with soil suitable for a burial place; that no active steps can be taken by the Town Council of the said borough to procure a burial site until all necessary powers are vested in them for providing a place of burial for the said parish under the provisions of the 17th and 18th Victoria, cap. 87, and praying that powers may be vested in the Town Council of the said borough
