THE FAIRS ACT, 1873.
SAINT NEOTS FAIR.

IN pursuance of the above-mentioned Act, I, the Right Honourable Sir William Vernon Harcourt, one of Her Majesty's Principal Secretaries of State, hereby notify as follows :

1. By Memorial, dated the 1st day of May, 1882, a representation has been duly made to me by the Justices acting in and for the Petty Sessional Division of Toseland, in the county of Huntingdon, that a Fair has been annually held on 17th day of December at St. Neots, in the said division of the said county, and that it would be for the convenience and advantage of the public that the day for the holding of such Fair should be altered, and that instead of being held as aforesaid, such Fair should in future be held on the Thursday preceding the 17th December in each year.

2. On the 27th day of June, 1882, I shall take the aforesaid representation into consideration, and all persons are to intimate, before that day, any objection they may desire to offer to the said proposed alteration in the time for holding the said Fair.

TENDERS FOR LOANS ON TREASURY BILLS.

1. THE Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England, on Friday, the 2nd proximo, at one o'clock, for Treasury Bills to be issued under the Act 40 Vic., cap. 2, to the amount of £1,500,000.

2. The Bills will be in amounts of £1,000, £5,000, or £10,000. They will be dated the 7th day of June, 1882, and will be payable at three or six months after date (at the option of the persons tendering), viz. :—on the 7th September or 7th December next, respectively.

3. The Tenders must specify the net amount per cent. which will be given for the amounts applied for; and the tenders of private individuals must be made through a London Banker.

4. The Bills will be issued and paid at the Bank of England.

5. The persons whose Tenders are accepted will be informed of the same on Saturday, the 3rd proximo, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England not later than three o'clock, on Wednesday, the 7th proximo.

6. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.
