The following area (namely),—so much of the townships of Tideswell, and Whetton, in the county of Derby, as lies within the following boundaries, that is to say, Monks Dale brook on the south and south-west from Millers Dale to Wormhill, and Tideswell-road as far as that point where the brook crosses the road at Bramwall Dale, and from thence on the west and north by Bramwall Dale-road to Summer Cross, and roads leading from that place known as Slancote-lane and Naylors-lane to Millers Dale Old-road, and on the east by Millers Dale Old-road to Monks Dale brook at Millers Dale,—which was declared by Order of Council dated the eighteenth day of April, one thousand eight hundred and eighty-two, to be an area infected with foot-and-mouth disease, is hereby declared to be free from foot-and-mouth disease, and that area shall, as from the commencement of this Order, cease to be an area infected with foot-and-mouth disease.
