lies within the following boundaries, that is to say, Green Man bridle-road to Bloxholm-road on the south, Bloxholm-road to Dunston Heathlane on the west, Dunston Heath-lane to Lincoln and Sleaford low-road on the north, and Lincoln and Sleaford low-road to Green Man bridle-road aforesaid on the east.

Northamptonshire.—The parishes of Barby, and Kilsby, in the county of Northampton.

Nottinghamshire.—(1.) In the county of Nottingham, comprised within the following boundaries, that is to say, the occupation-road leading from Annesley Kennels to Lodge farm in the parish of Annesley, from Lodge farm by the fence leading along the south side of High Park Wood in the parish of Greasley, from High Park Wood along the fence leading to Mrs. Ball's house on Hucknall Common, and from Mrs. Ball's house on the west side by the fence leading over the hill to the occupation-road leading from Hucknall to Annesley Kennels.

(2.) So much of the parish of Holme, in the county of Nottingham, as lies within the following boundaries, that is to say, on or towards the north by Langford-lane and Wells-lane leading from the Gainsborough-road to the Trent, on or towards the east by the said Gainsboroughroad leading from Winthorpe School to Langford-lane End, on or towards the south by a straight line from Winthorpe School to the river Trent, and on or towards the west by the river Trent.

Shropshire.--(1.) So much of the parish of Baschurch, in the county of Salop, as lies within the following boundaries, that is to say, the water-course from Walford Heath to Fenemere brick-yard, thence the boundary fence which divides T. Slaney Eyton's property to the highway leading from Merrington Green to Walford Heath water-course aforesaid.

(2.) So much of the parish of Forton, in the county of Stafford, and of the township of Chetwynd Aston, in the county of Salop, as lies between the following boundary, that is to say, the main-road from Newport to Coley Mill, Moreton brook, the Shropshire Union Railway, and the brook which runs from near Chetwynd Aston village to the main-road aforesaid.

(3.) So much of the parish of Forton, in the county of Stafford, and of the parish of Newport and the township of Chetwynd Aston, in the county of Salop, as is bounded by the main-road from Coley Mill to Newport, Tanhouse-lane, the Shropshire Union Canal, Meertown brook, Aqualate Meer, and Moreton brook.

(4.) So much of the parishes of Stoke-upon-Tern, and Hodnet, in the county of Salop, as lies within the following boundaries, that is to say, the highway leading from Ollerton village to a stream crossing the road between Eaton village and Great Bolas, thence the stream to the river Teen, thence the river Teen to Little Bolas Bridge, thence the highway to Peplow Church, and thence the foot-path to Ollerton village aforesaid.

Staffordshire.—(1.) So much of the parish of Longdon, in the county of Stafford, as lies on the north-eastern side of the turnpike-road from Lichfield to Rugeley, and on the south-eastern side of How brook.

(2.) So much of the township of Branstone, in the county of Stafford, as lies within the following boundaries, that is to say, the river Trent from Drakelow Viaduct to Trent House Branstone, thence by the Flood Embankment to the Midland Railway leading from Burtonupon-Trent to Tamworth at Branstone village, thence by the said railway to Branstone Junction, and thence by the Birmingham Curve and the Burton-upon-Trent and Leicester line of railway to the river Trent at Drakelow Viaduct aforesaid.

(3.) So much of the parish of Forton, in the county of Stafford, and of the township of Chetwynd Aston, in the county of Salop, as lies between the following boundary, that is to say, the main-road from Newport to Coley Mill, Moreton-brook, the Shropshire Union Railway, and the brook which runs from near Chetwynd Aston village to the main-road aforesaid.

(4.) So much of the parish of Forton, in the county of Stafford, and of the parish of Newport and the township of Chetwynd Aston, in the county of Salop, as is bounded by the main-road from Coley Mill to Newport, Tanhouse-lane, the Shropshire Union Canal, Meertown brook, Aqualate Meer, and Moreton brook.

(5.) So much of the townships of Dunstall, and Tatenhill, in the county of Stafford, as lies between the main-road from Burton-upon-Trent to Lichfield, the highway from Bartonunder-Needwood village to the cross-roads at the southern end of Tatenhill village, and the highway thence to Branstone.

(6.) So much of the parish of Gayton, in the county of Stafford, as lies within the following boundaries, that is to say, the highway from Coton by Doglands to Gayton village, the highway thence through Gayton village to Hartley Green, and the road from Hartley Green direct to Fradswell in the township of Fradswell and the parish of Gayton.

Warwickshire.—(1.) So much of the hamlet of Erdington, in the county of Warwick, as lies within the following boundaries, that is to say, the Midland railway on the south, Chester-road on the east, Grange-lane on the north, and the road leading from Bromford to Erdington on the west.

(2.) The whole of the parish of Bulkington, in the county of Warwick.

Wiltshire.—(1.) At Laverstock and Ford, in the county of Wilts, bounded on the north by a row of elm-trees extending from a pond called Read's pond on the eastern side of the old turnpike-road from Salisbury to Amesbury to a field called Buckle Corner, on the east by a row of elm-trees extending from Buckle Corner to a field called The Sling, on the south by a bank and fence extending from The Sling to a plantation called Rockshill plantation, and thence by the northern boundary of such plantation to the old turnpike-road from Salisbury to Amesbury, and on the west by the eastern boundary of the said turnpike-road. (2.) So much of the parishes of Stratford,

(2.) So much of the parishes of Stratford, and Fugglestone St. Peter, in the county of Wilts, as lies within the following boundaries, that is to say, on the north by the southern fence of the main-road from Wilton to Woodford from the Direction Post at New Cut on the Devizes-road to the top of Camp Hill, from thence by a straight line across the Down to Little Durnford Lodge, and on the east by the eastern fence of and including the mainroad from Woodford to Salisbury from Little Durnford Lodge to the county bridge crossing the river Avon at Stratford-sub-Castle, and
