Pending arrangement being made at Camaran they are to undergo quarantine at a small island near Jeddah."

It appears from another telegram sent by Her Majesty's Ambassador that vessels from Singapore, not laden with pilgrims, are also now admitted to pratique in Ottoman Ports.
