#### Civil Service Commission, July 11, 1882.

THE Civil Service Commissioners hereby give notice that, with the approval of the Lords Commissioners of Her Majesty's Treasury, the following amendment has been made in the Regulations respecting Competitive Examinations, held under the Orders in Council of 4th June, 1870, and 12th February, 1876, for Second Class Clerkships in the India Office, Second Class Clerkships in the India Audit Office, and Men Clerkships of the Lower Division of the Civil Service, which Regulations were published in the London Gazette of the 8th July, 1881, viz.:—

In Clause 2 (iv), after the word "competition" the words "and for removal from the list under Clause 8 of the Order in Council of the 12th February, 1876," are inserted.

#### Civil Service Commission, July 11, 1882.

THE Civil Service Commissioners hereby give notice, that the following Regulations have been approved by the Lords Commissioners of Her Majesty's Treasury, viz.:—

**SPECIAL REGULATIONS** (Supplementary to the General Regulations issued 8th April, 1872, and amended by subsequent notices in the London Gazette), respecting Open Competitive Examinations for the situation of Draughtsman in the Department of the Commissioners of Patents.

I. The limits of age for this situation are 22 and 30, and Candidates must be of the prescribed age on the first day of the Examination.

II. Candidates will be required to show what preliminary training or technical education they have undergone to qualify themselves for a situation of this nature. They must have been engaged for at least three years during the last
