NOTICE is hereby given, that the Mayor, Aldermen, and Burgesses of the borough of Bolton, in the county of Lancaster, hereinafter called "the Corporation," intend, with the consent of the Board of Trade, by lease to be approved by that Board, to demise to Joseph Walker, of Broomhurst, Eccles, in the county of Lancaster, John Greenwood, of Bolton Lodge, Eccles aforesaid, and Edmund Holden, of Bolton aforesaid, Coach and Omnibus Proprietor, carrying on business in partnership, under the firm of Edmund Holden and Company, the right of user by the said Joseph Walker, John Greenwood, and Edmund Holden of the tramways which have been completed by the said mayor, aldermen, and burgesses, under the authority of the Bolton and Suburban Tramways Order, 1878, and the right of demanding and taking in respect of the same certain tolls and charges, to hold for the term of 21 years from the 17th day of December, 1880, at the yearly rent of £5,803 10s. 10d., and also, when the lessees shall have commenced to use steam or other mechanical motive powers on the said tramways, the further yearly rent of £103 7s. 8d.

And further, that the following is a general description of the covenants and conditions contained in the lease, that is to say:—

Covenants by the lessees.

To pay the rents reserved by the lease, and all rates, taxes, assessments, and outgoings (except Flandlord's property and income tax), in respect of the promises. To run carriages at cheap fares for labouring classes. To use the tramways for traffic in accordance with the bye-laws and regulations. To observe bye-laws and regulations from time to time made by the Corporation with regard to the tramways. To concur with the Corporation in the making of regulations for preventing nuisance or other offence in relation to the tramways, and to enforce the observance thereof. Not to permit the tramways to be used for the conveyance of animals, goods, materials, articles, or things, except such passengers' luggage and otherwise as in the lease mentioned, nor permit advertisements to be affixed to the carriages except in accordance with regulations. Not to

use other than animal motive power, except with the consent of the Corporation. To indemnify the Corporation in certain cases. Not to interfere with the rails and plates. To be answerable for any trespass for damage (other than reasonable wear and tear) done by the horses or servants of the lessees. To give the Corporation notice of defects in the tramways. To permit the Corporation to use the tramways, and not to assign, underlet, or part with the demised premises without the consent of the Corporation.

Covenants by the Corporation.

For quiet enjoyment by the lessees and to maintain the tramways.

Conditions enabling the Corporation to require payment of the reserved rents one quarter in advance, and to distrain for rent in arrear. For determining the lease in case of bankruptcy, composition, or liquidation by arrangement. For re-entry on non-payment of rent or breach of the lessees' covenants. Saving powers for the breaking up of roads for gas, water, telegraphs, sewers, and other purposes subject to restrictions and conditions, and for the reference of disputes to arbitration.

And notice is hereby further given, that a copy of the said lease is deposited for public inspection in the Town Clerk's office, at the Townhall of the said borough.

In the High Court of Justice.—Chancery Division.
Mr. Justice Kay.

Transferred from Vice-Chancellor Hall.
In the Matter of the Companies Acts, 1862 to 1880, and in the Matter of the New Zealand Land Corporation Limited.

BY an Order made by Mr. Justice Kay in the above matter, dated the 7th day of July, 1882, on the petition of Leonard Harland, of
