B. A declaration by a competent authority based on the certificate of an official expert,

(a.) That the articles come from a plot of ground separated from the nearest vine-plant by a space of at least 20 mètres, or by such obstacle as the competent authority may judge sufficient to isolate the roots.

(b.) That the plot itself contains no vine-plant.

(c.) That no vine-plant or portion thereof has

recently been deposited on such plot.

(d.) That if phylloxerated vines have been thereon, the roots have been torn up, the proper poisons have been applied, and that during three years investigations have been made which assure the complete destruction of the insect and the roots.
