

Also to incorporate the said Joint Committee, or otherwise, provide for the more convenient signing and authentication of contracts, agreements, and other documents by or for and on their behalf.

Also to vary or extinguish all rights and privileges which might in any way prevent or interfere with the accomplishment of any of the objects of the intended Act, and to confer other rights and privileges.

Also to repeal or amend all or some of the provisions of the said Acts of 1879, 1881, and 1882, and of the several Acts of Parliament following, or some of them, that is to say—The Metropolitan Railway Company's Acts passed in each and every of the years 1854 to 1857, 1859 to 1875, and 1877 to 1882, all inclusive, and all other Acts relating to or affecting the Metropolitan Railway Company, and 27 and 28 Vic., cap 322, and all other Acts relating to or affecting the Metropolitan District Railway Company.
