OTICE is hereby given, that application is intended to be made to Parliament in the ensuing session, by the South London Tramways Company (hereinafter called "the Company"), for an Act for all or some of the following

purposes, that is to say :-

To empower the Company to make, form, lay down, and maintain, the several tramways hereinafter described, or some or one of such tramways, with all necessary and proper rails, plates, sleepers, works, and conveniences connected therewith, that is to say:

Tramway No. 1 (single line), commencing in North-street, Wandsworth, by a junction with the westernmost line of rails of the existing tramway of the Company at a point about i of a chain, measured in a northerly direction along that street, from the termination of such existing tramway, and terminating in East Hill, Wandsworth, at a point about $\frac{1}{2}$ a chain, measured in a south-westerly direction along that Hill, from

Tonsley Hill, Wandsworth. Tramway No. 2 (double line), commencing at the termination of the intended Tramway No. 1 as hereinbefore described, and terminating in East Hill aforesaid at a point about 1½ chains, measured in a north-easterly direction along that Hill, from Tonsley Hill

aforesaid.

Tramway No. 3 (single line), commencing at the termination of Tramway No. 2 as hereinbefore described, and terminating in East Hill aforesaid by a junction with the termination of the existing tramway of the Com-

pany at East Hill aforesaid.

Tramway No. 4 (double line), commencing in Queen's-road, Clapham, by a junction with the existing tramway of the Company at a point about $\frac{3}{4}$ of a chain, measured in a northerly direction along that road, from Lavender Hill, Clapham, and terminating in Cedars-road, Clapham, at a point about $3\frac{1}{4}$ chains, measured in a southerly direction along that road, from Lavender Hill aforesaid.

Tramway No. 5 (single line), commencing in Lavender Hill aforesaid by a junction with the existing tramway of the Company at a point about ½ of a chain, measured in a westerly direction along that Hill, from Cedars-road aforesaid, and terminating in Cedars-road aforesaid by a junction with No. 25172.

the westernmost line of the intended Tramway No. 4, at a point about ½ of a chain, measured in a southerly direction along that road, from Lavender Hill aforesaid.

Tramway No. 6 (single line), commencing in Cedars-road aforesaid by a junction with the Westernmost line of the intended Tramway No. 4 at a point about 3 of a chain, measured in a southerly direction along that road, from Lavender Hill aforesaid, and terminating in Cedars-road aforesaid by a junction with the easternmost line of the intended Tramway No. 4 at a point about 12 chains, measured in a southerly direction along that road, from Lavender Hill aforesaid.

Tramway No. 7 (single line), commencing at the point of termination of the intended Tramway No. 4 as hereinbefore described, and terminating in Cedars-road aforesaid at a point distant from its point of commencement $15\frac{1}{2}$ chains or thereabouts, measured in a southerly direction, from its point of commencement.

Tramway No. 8 (double line), commencing at the point of termination of the intended Tramway No. 7 as hereinbefore described, and terminating in Cedars-road aforesaid at a point distant from its point of commencement 24 chains or thereabouts measured in a

southerly direction.

Tramway No. 9 (single line), commencing at the point of termination of the intended Tramway No. 8 as hereinbefore described, and terminating in the High-road on Clapham-common (leading from Battersea Rise in an easterly direction to Balham Hill-road) at a point about 9 chains, measured in an easterly direction along the said High-road, from Cedars-road aforesaid.

Tramway No. 10 (double line), commencing at the point of termination of the intended Tramway No. 9 as hereinbefore described, and terminating in the last-mentioned Highroad on Clapham-common at a point about 2½ chains, measured in an easterly direction along that High-road, from the commencement

of the Tramway.

Tramway No. 11 (single line), commencing at the point of termination of the intended Tramway No 10 as hereinbefore described, and terminating in the before-mentioned road on Clapham-common at a point about 7 chains, measured in a westerly direction from Balham Hill-road.

Tramway No. 12 (double line) commencing at the point of termination of the intended Tramway No. 11 as hereinbefore described, and terminating in the before-mentioned road on Clapham-common at a point about 4½ chains, measured in a westerly direction along that road, from Balham Hill-road.

Tramway No. 13 (single line) commencing at the point of termination of the intended Tramway No. 12 as hereinbefore described, and terminating in Balham Hill-road at a point about 4 chains, measured in a southwesterly direction along that road, from Clarham Park-road.

Tramway No. 14 (double line) commencing at the point of termination of the intended Tramway No. 13 as hereinbefore described, and terminating in Balham Hill-road aforesaid at a point about 2 chains, measured in a south-westerly direction along that road, from Clapham Park-road.

Tramway No. 15 (single line), commencing at the point of termination of the intended
