

intended to be taken into the intended Reservoir No. 1, by means of that reservoir and the intended aqueduct, conduit, or line of pipes No. 1, and all or some of the streams and waters in the line of the proposed works, or within the limits of deviation defined upon the plans hereinafter mentioned relating to the waterworks, or which can or may be taken or abstracted by means of the said intended works or any of them, which waters now proceed directly or derivatively into the River Alyn and the River Dee or one of them.

6. To make effectual provisions for the protection of the waterworks and property of the Company, and for preventing the waste, fouling, and misuse of water, and for defining and regulating the supply of water by them, whether by meter or otherwise, and the terms and conditions of such supply.

7. To deviate laterally from the lines of the intended waterworks within the limits shown upon the plans hereinafter mentioned, or as may be provided by the Bill, and whether within or beyond the limits of deviation allowed by "The Waterworks Clauses Act, 1847," and to deviate vertically to any extent from the levels of those works, as shown upon the sections hereinafter mentioned.

8. To authorise the Company to purchase by compulsion or agreement all or some of the following lands, that is to say:—

A piece or parcel of land 2 acres or thereabouts in extent, situate in the township of Pentrobin, in the parish of Hawarden, in the county of Flint, at or near the Buckley Station on the Wrexham, Mold, and Connahs Quay Railway, and adjoining and on the eastern side of that railway, and forming portions of three fields numbered respectively 128, 159, and 160 in the said parish of Hawarden on the 25-inch Ordnance map of that parish,

and thereon or on any part thereof to erect, make, maintain, alter, improve, enlarge, extend, and renew, or discontinue gasworks, retorts, gasometers, receivers, purifiers, drains, mains, pipes, meters, machinery, and other apparatus, works, and conveniences for the manufacture, conversion, utilization, storage and supply of gas and coke, and other residual products obtained in the manufacture of gas and matters producible therefrom, and to make, store, and supply gas, and to manufacture, convert, store, sell, supply, and deal in coke, tar, pitch, lime, ammoniacal liquor, oil, and other residual products arising or resulting from the manufacture of gas and matters producible therefrom.

9. To manufacture, purchase, provide, sell, let on hire, and fix stoves, ranges, meters, fittings, engines, machinery, apparatus, and appliances for lighting, for motive power, for heating, cooking, ventilating, manufacturing, agricultural, industrial, or any other purpose whatsoever, and to supply or work the same by means of gas.

10. To acquire, hold, use, and exercise patent rights and licences in relation to the manufacture and distribution of gas and the utilization of residual products, and to manufacture, purchase, sell, let on hire, or otherwise deal in meters, tubes, pipes, lamps, burners, fittings, and other apparatus, articles, and things used in the supply of water or gas, residual or other products and substances aforesaid, and to erect, fit up, and maintain and let houses, cottages, and dwellings for the officers and servants of the Company, and to have, hold, use, and enjoy and exercise all powers, rights, privileges, and

authorities necessary, proper, or convenient for the purposes aforesaid, and generally to carry on the business usually carried on by water and gas Companies.

11. To purchase by compulsion or agreement, and acquire and to take on lease, and to take grants of easements over any lands, houses, springs, streams, waters, and other hereditaments within the parishes, townships, and places mentioned in this notice, or any or either of them, which may be required for the purposes of the intended reservoirs, waterworks, and gasworks, or otherwise requisite or desirable for the purposes of the Bill, and to vary and extinguish all rights and privileges connected therewith.

12. To produce and supply light, heat, and motive power by means of electricity or other like agency, and for or in connection with any such purpose to use any lands belonging to or held on lease by them, and to purchase by agreement and take on lease any lands, to erect and maintain workshops, engine-houses, storehouses, or other buildings and places for storing electricity or other like agent for producing light, heat, or motive power. To manufacture, buy, or hire, use, supply, and let machinery, steam-engines, gas-engines, and other apparatus, meters, and fittings. To buy any gas or fuel, or buy or rent any other motive power, or buy, rent, and sell, or let any materials or articles, or to acquire licences for themselves or any persons, companies, or corporations licensed or supplied by them for the use of any patented or protected processes, inventions, machineries, methods, materials, or other things, and to exercise any powers which, under the Gasworks Clauses Act, 1847, or the Gasworks Clauses Act, 1871, or any other Act, may be exercised by undertakers for the purposes of any gas undertaking. To prescribe the limits within which any such powers as aforesaid may be exercised, and to provide for the payment of any expenses incurred by the Company in connection with the exercise of such powers, and for the application of any revenue or receipts of the Company arising therefrom, and to make all other provisions necessary or incident to the exercise of any such powers.

13. To levy and receive rates, rents, and charges, differential and otherwise, for or in respect of the supply of water and gas and electricity and for the sale and hire of meters, fittings, stoves, ranges, engines, machinery, apparatus, and appliances, to alter existing rates, rents, and charges, and to confer, vary, and extinguish exemptions from the payment of rates, rents, and charges.

14. To lay down, maintain, take up, alter, and repair mains, pipes, culverts, conduits, sluices, drains, and other works in, through, under, over, across, and along, and to cross, break up, open, alter, divert, stop up, or otherwise interfere with, either temporarily or permanently, any turnpike or other roads, highways, footways, streets, squares, alleys, public places, bridges, canals, navigations, towing-paths, railways, tramways, works, pipes, sewers, drains, rivers, streams, brooks, and watercourses in any of the parishes, townships, and places beforementioned, so far as may be necessary or convenient for all or any of the purposes of the Bill.

15. To enable the Company on the one hand, and the Local Board for the district of Mold (hereinafter called "the Local Board") and the Mold Gas and Water Company (hereinafter called "the Old Company"), or any other sanitary authority, company, corporation, local board, public body, officers, or persons on the
