7. IV, cap. 90; 38 and 39 Vic., cap. 29; "The Pier and Harbour Orders Confirmation Act, 1878 (No 1)"; "The Pier and Harbour Orders Confirmation Act, 1882 (No 1)," and all other Acts, if any, relating to the pier or which may relate to or be affected by the Order.
