(Application to the Board of Trade by the Corporation of Accrington, for a Provisional Order Authorising the Corporation to Supply Electricity for any Public or Private Purposes within the Area of the Borough of Accrington; Construction of Works; Breaking-up of Private Roads, &c.; Regulations as to Supply, &c.; Acquisition of Lands, Licenses, &c.; Trans-

ference of Powers; Alterations of Pipes and

Wires under Streets; and other Powers).

Notice is hereby given, that application is intended to be made to the Board of Trade by the Mayor, Aldermen, and Burgesses of the borough of Accrington, in the county palatine of Lancaster, being the Urban Sanitary Authority and Local Authority for the said borough within the meaning of the Electric Lighting Act, 1882 (hereinafter referred to as the Corporation), pursuant to the provisions of the said Act for a Provisional Order for the following, or some of

the following, among other purposes:—

1. To authorise the Corporation, for a period to be defined by the said Provisional Order, to supply, within an area co-extensive with the borough of Accrington, such area being their own sanitary district, electricity for the purpose of lighting any street or any place belonging to or subject to the control of the Corporation, or any church, or registered place of public worship, or any hall or building, belonging to, or subject to the control of any public authority, or any public theatre, or for any public or private purposes whatever, to which electricity may for the time being be applicable, except the transmission of any telegram.

2. To authorise the Corporation, upon any lands

belonging to or hereafter to be acquired by them for the purposes of the said Provisional Order, to make, construct, erect, maintain, remove, and renew any buildings, machinery, engines, apparatus, works, matters, or things of whatever description required to supply, measure, and regulate the supply of electricity, together with all electric lines (which expression "electric line" means a wire or wires, conductor, or other means used for the purpose of conveying, transmitting or distributing electricity, with any casing, coating, covering, tube, pipe, or insulator enclosing, surrounding, or supporting the same, or any part thereof, or any apparatus connected therewith for the purpose of conveying, transmitting, or distributing electricity or electric currents), and generally to carry into effect the object of the Corporation under the said Provisional Order and the said Electric Lighting Act, 1882.

To authorise the Corporation to place, lay down, set up, maintain, renew, and remove electric lines or other works in, over, or along the streets, squares, courts or alleys, highways, lanes, roads, thoroughfares, or public passages or places already made, and in, over, or along all other streets hereafter to be made, formed, and contracts the streets hereafter to be made, formed, and con-

structed within the said area of supply.

4. To authorise and empower the Corporation to enter upon and break up the streets, roads, ways, footpaths, railways, tramways, and other places specified and described in the schedule hereto, and to enter upon and break up any other streets hereafter to be made, formed and constructed within the said area of supply, and not
