Euston and Marylebone-road Tramways.

(Construction of Tramways in the parishes of St. Pancras and St. Marylebone, in the county of Middlesex; Agreements with Local Authorities; Repeal and Amendment of Acts; and other Purposes.)

OTICE is hereby given, that application is intended to be made to the Board of Trade for a Provisional Order, pursuant to the

provisions of the Tramways Act, 1870, to authorize and empower the Promoters to effect the objects and purposes hereinafter mentioned, or some of them, that is to say:—

To make, form, lay down, and maintain the several tramways hereinafter described, or some of them, with all necessary and proper rails, sleepers, turn tables, works, and conveniences connected therewith respectively, that is to say:—

Tramway No. 1. A double line, whole situate in the parish of St. Pancras, in the county of Middlesex, commencing in the Euston-road, at a point about 22 yards east of the south-west corner of St. Pancras-road, thence passing westward along the Euston-road to and terminating at a point in the same road about 22 yards west of the north-west corner of Judd-street.

Tramway No. 2. A double line, wholly situate in parishes of St. Pancras and St. Marylebone, in the county of Middlesex, commencing by a junction with Tramway No. 1, at its termination, thence passing westward along the Euston-road to and terminating at a point in the same road opposite Osnaburgh-street, in the said parishes, or one of them

Tramway No. 3. A double line, wholly situate in the said parish of St. Marylebone, commencing by a junction with Tramway No. 2, at its termination, thence passing westward along the Marylebone-road, to and terminating in the said road at a point about 14 yards eastward of the centre of the Edgware-road.

To provide that the said tramways shall be con-

structed on a gauge of 4 feet 81 inches.

To authorize and empower the Promoters from time to time to enter upon or open and break up the surface of and to alter and to stop up, remove, and otherwise interfere with, streets, roads, highways, tramways, public works, ways, footpaths, sewers, drains, pavements, thoroughfares, water pipes, gas pipes, and electric telegraph posts, pipes, tubes, wires, and apparatus, within all or any of the parishes and places mentioned in this notice, for the purpose of constructing, maintaining, repairing, removing, renewing, altering, or reinstating the proposed tramways and works, or of substituting others in their place or for other purposes of the intended Order.
