1. To enable the Corporation to supply and sell electricity for all or any public and private purposes, within the area of the city of Chichester.

2. To enable the Corporation to erect, construct, make, and maintain, on any lands now belonging to them, or which they may hereafter acquire, buildings, engines, machinery, appliances, and works requisite for generating, producing, storing, supplying, and distributing electricity, and for those purposes to exercise all or any of the powers of "The Electric Lighting Act, 1882," of the "Gas Works Clauses Act, 1847," and "The Gas Works Clauses Act, 1871," and such other rights and powers as may be conferred by the Order.

3. To enable the Corporation to levy, charge, and recover rates and rents, and to make, lay down, erect, construct, make, and maintain all such works, buildings, engines, machinery, mains, wires, posts, standards, brackets, insulators, conductors, approaches, appliances, matters and things as may be necessary or expedient for all or any of the purposes afore-

said.

4. The proposed area of supply shall be taken to be the area of the city of Chichester, as such area is defined by, and comprised within, the municipal boundaries of the city of Chichester.

5. To enable the Corporation to break up, stop up, or interfere with, and to cross or pass over, under, or along, as the case may require, public and private streets, roads, squares, courts, alleys, paths, passages, lanes, ways, and thoroughfares, railways, tramways, canals, rivers, streams, watercourses, bridges, spaces, and places within the said area of the said city of Chichester, and any sewers, drains, pipes, and telegraph or telephonic apparatus, in, over, or under the same

respectively.

6. The names of the streets and other places in, over, or along which it is proposed to place any electric lines, or other works, are hereinafter mentioned, that is to say, Basin-road, by the Basin, behind the Infirmary, Baffin's-lane, Cathedral-yard, and approaches to the Cathedral, The Cloisters, Cannon-lane, Cavendish-street, Chapel-street, Canal-road, Crane-street, Cooperstreet, Cross-street, Champion-court, Cattlemarket-road, Cattle-market, College-lane, Crooked S, Dell-hole, East Pallant, East-street, Elm-grove, East-row, East-gate, East-walls, East-gate-East-row, East-gate, cast-man, square, Franklyn-place, Fairfield-lane, Green-lane, G square, Franklyn-place, Fairfield-lane, Farr's-court, Fishbourne-road, Green-lane, Guilden-road, Guildhall-street, George-street, High-street, Kitson's-yard, Langley's-yard, Lennox-place, Love-lane, Lion-street, Little London, North Pallant, North-street, North Orchard-street, North-gate, North-walls, New Broyle-road, Near the barracks, New Town, New-road, Oving-road, opposite the workhouse, Old Broyle-road Orchard-place, Orchard-street. old Broyle-road, opposite the workhouse, Old Broyle-road, Orchard-place, Orchard-street, Orchard-terrace, Parchment-street, Priory-lane, Priory-street, Priory-road, Saint Richard's walk, South-gate, Stockbridge, South-street, South-Pallant, St. Paul's-road, St. Paneras, Spitalfieldslane, Saint Martin's-street, Saint Martin's-square, St. Martin's-lane, Shamble-alley, Saint John's-street, Theatre-lane, Tower-street, The Hornet, Vicar's-close, West Pallant, West-gate, West-street, West-end, Washington-street, Wellington-row, Walker's-court, Whyke-lane, and all other, if any, streets, squares, roads, ways, paths, passages, lanes, courts, alleys, thoroughfares, open spaces and other public places within the said area of the said city of Chichester, repairable by the Corporation.

7. The streets and other places in, over, or along which it is proposed to place any electric

lines or other works or appliances, not repairable by the Corporation, are as follows, that is to say, Adelaide - road, Cawley - road, Caledonian - road, Lyndhurst - road, Whyke - lane, and any other street, road, way or open space not so repairable situate in the Old Cherry Orchard or elsewhere in the said area of the said city of Chichester.

8. The railways and canals which the Corporation propose to take powers, by the said Order, to pass or cross over, under, or along, and break up. so far as they are respectively situate in the said area of the said city of Chichester, are the

following, that is to say :-

Railways.—The London, Brighton, and South Coast Railway. The Chichester and Midhurst Railway. And all lines, branches, sidings and stations belonging to, and used by the London, Brighton and South Coast

Railway Company.

anals. — The Portsmouth and Chichester

Canal and the Basin thereof,

9. To authorise the Corporation to manufacture and supply, or to contract with any Company or person to manufacture and supply, electricity, and to hire, sell, and let electricity, and meters, burners, lamps, engines, machinery, works, appliances, and apparatus, for and in relation to the production, supply, distribution, and utilisation of electricity, or for generating the same, and to make and recover rents and charges therefor.

10. To enable the Corporation to acquire, hold, and use, or to contract with any person, Comcany, or persons for the use of patent rights or icenses and authorities, under letters-patent, for the use of inventions, appliances, and apparatus, for or relative to the production, supply, or utilisation and distribution of electricity, or for

generating the same.

11. To enable the Corporation and any Company or person to enter into and fulfil contracts and agreements, for and in relation to all or any of the purposes before-mentioned, and to enable the Corporation to sell, demise, or let to such Company or person, any lands for the time being belonging to the Corporation, and to enable them to acquire lands by agreement for all or any of the purposes of the intended Order.

12. To incorporate with the intended Provisional Order, with or without alteration, the provisions or some of the provisions of "The Gas Works Clauses Act, 1847;" "The Gas Works Clauses Act, 1871;" and "The Lands Clauses Consolidation Acts, 1845, 1860, and 1869," except the provisions of the last-mentioned Acts relating to the purchase and taking of lands other-

wise than by agreement.

13. On or before the 30th day of November instant, a copy of this Notice, as published in the London Gazette, and a map showing the proposed limits or boundaries of the proposed area of supply and the streets and other places in, over, or along which it is proposed to place any electric lines or other works, will be deposited for public inspection with the Town Clerk of the city of Chichester, at his office in Chichester; with the Clerk of the Peace for the city of Chichester, at his office, in Chichester; with the Clerk of the Peace for the county of Sussex, at his office, at Lewes; and also at the office of the

Board of Trade, Whitehall, London.
