the rights, privileges, jurisdictions, functions, powers, authorities, duties, and liabilities, now belonging to, vested in, enjoyable; and exercisable by, imposed upon, and affecting the Commissioners.

2. To authorise the Commissioners for the purposes of the said Acts or other the purposes of the Commissioners, by agreement to purchase and hold lands, houses, and hereditaments, and to take grants of and to exercise and enjoy easements, rights, or privileges in, over, or affecting lands, houses, and hereditaments, and to empower persons under disability to sell, convey, and grant to the Commissioners lands, houses, and hereditaments, and any easements, rights, or privileges in, over, under, or affecting the same, and to vary or extinguish all rights and privileges in any manner connected therewith.

3. To authorise and empower the Commissioners from time to time to make, alter, and repeal bye-laws for all or any of the purposes for which bye-laws may be made under the Commissioners Clauses Act, 1847, and also for the following, among other purposes, or some of them (that is to say):--

- For prohibiting persons discharging any refuse or other offensive matter into any channel, drain, or watercourse, for the time being under the control of the Commissioners, or otherwise fouling the water thereof, or throwing, or suffering to fall, any earth, stones, or soil into any such channel, drain, or watercourse.
- For prohibiting persons from cutting tunnels or drains into, through, or under, or otherwise injuring any drain, sluice, watercourse, or work, for the time being under the control of the Commissioners.
- For prohibiting persons from defacing or removing marks placed by authority of the Commissioners on any work for the time being under the control of the Commissioners.
- For prohibiting persons from injuring, defacing, or removing notices, placards, and notice boards put up by the Commissioners, and any fences connected with the works of the Commissioners.

4. To make provision with respect to the allowance, disallowance, hearing of objections to, inspection, and publication of such bye-laws.

5. To impose and provide for the recovery and application of penalties for the breach or nonobservance of any such bye-laws or any provisions of the said Acts or the Bill.

6. To empower the Commissioners for the purposes of the Bill and of the said Acts, and for discharging existing debts and liabilities, and for other purposes of the Commissioners, to borrow money on mortgage or bond, on the security of the rates, taxes, and charges which they are now authorised to levy under the said first-mentioned Act, and to provide for the paying off and discharging of any moneys so borrowed by annual instalments or a sinking fund, or otherwise.

7. To confer on the Commissioners all powers, rights, authorities, and privileges incidental to, or necessary for carrying into complete and full effect the objects and purposes of the Bill, to vary and extinguish all rights and privileges which would interfere or be inconsistent with those objects and purposes, and to confer other rights and privileges.

8. To incorporate with the Bill the provisions or some of the provisions of the Lands Clauses Consolidation Acts, 1845, 1860, and 1869, and the Commissioners Clauses Act, 1847.

9. To alter, extend, amend, and, so far as necessary or expedient, repeal the provisions or some of the provisions of the said local and personal Acts 52 Geo. 3, cap. 143, and 59 Geo. 3, cap. 77, and all other Acts which may relate to or be in any way affected by any of the objects and purposes of the Bill.
