

(FOOT-AND-MOUTH DISEASE.)

AT the Council Chamber, Whitehall, the 14th day of December, 1882.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. Each of the Areas described in the Schedule to this Order is hereby declared to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the sixteenth day of December, one thousand eight hundred and eighty-two.

SCHEDULE.

(1.) An Area comprising so much of the parish of Mansfield, in the county of Nottingham, as lies within the following boundaries, that is to say, the Mansfield and Southwell line of Railway from the Nottingham-road to the Southwell-road, the Southwell-road from the Railway Bridge to Lyndhurst-lane, Lyndhurst-lane through Mansfield Wood to the Old Turnpike-road, the Old Turnpike-road from Lyndhurst-lane to the Nottingham-road, and the Nottingham-road from the Old Turnpike to the Railway Bridge.

(2.) An Area at Orston, in the county of Nottingham, comprised within the following boundaries, that is to say, from Alverton boundary to Bottesford Crossing on the Great Northern Railway on the east, Bottesford-lane to Gillotts farm on the south, Lordship-lane, Spa-lane, and Mill-lane to Flawborough boundary in Long Edge-lane, and Flawborough boundary fence to Alverton-road on the west, and Alverton-road to Alverton boundary aforesaid on the north.

1. The following Area (namely),—so much of the parishes of Burton-Joyce, and Bulcote, in the county of Nottingham, as lies within the following boundaries, that is to say, the highway leading from Burton-Joyce to Lowdham from the Burton Police Station to Alveys Gunthorpe farm on the south, and from Alveys Gunthorpe farm by the Bulcote Hill farm boundary fence to the Burton Police Station aforesaid on the west, north, and east,—which was declared by Order of Council dated the fourteenth day of November, one thousand eight hundred and eighty-two, to be an Area infected with foot-and-mouth disease, is hereby declared to be free from foot-and-mouth disease, and that Area shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the sixteenth day of December, one thousand eight hundred and eighty-two.

(1.) An Area comprising the whole of the farm and lands known as the Parsonage farm, situate at Bardfield Saling, in the petty sessional division of Freshwell, in the county of Essex, in the occupation of Abraham Smith.

(2.) An Area at Panfield, in the petty sessional division of South Hinckford, in the county of Essex, comprised within the following boundaries, that is to say, the highroad leading from Panfield Church by Little Priory farm to the boundary of Panfield parish near Sheering Hall, then by the parish boundary to Bell-lane, and then by the highroad to Panfield Church aforesaid.

(3.) An Area comprising the lands known as Great Bardfield Hall farm, Lower Hall farm, and The Place farm, all in Great Bardfield, in the petty sessional division of Freshwell, in the county of Essex, all in the occupation of the Executors of the late Henry Smith.
