following the said township boundary north-

eastwards to the point aforesaid.

(5.) So much of the township of Terrington, in the North Riding of the county of York, as lies within the following boundaries, that is to say, a brooklet leading from Wiganthorpe Lake to Terrington Flooding-Pond on the north, thence a brooklet to Ganthorpe Brickyard on the east, thence a quickwood fence to the Terrington and Mowthorpe highway, thence a quickwood fence in a straight line to Sideing's Beck, by Sideing's Beck to a quickwood fence at the low side of Prospect House on the south, the said fence which passes on the west side of Prospect House in a straight line to the Terrington and Flat-Top highway on the west, and thence a quickwood fence to Wiganthorpe Lake

Forkshire (West Riding).—(1.) At Crofton, in the West Riding of the county of York, comprised within the following boundaries, that is to say, the Wakefield and Ponte-front and from the Cook and Crown Inc. fract-road from the Cock and Crown Inn at Crofton to. West-lane on the north, West-lane, Castle-fence, and Spring-lane to Santingley-lane on the east, and the highway from Spring-lane through Crofton village and Cock-lane to the junction of the roads at the Cock and Crown Inn at Crofton afcresaid on the south and west.

(2) At Tockwith, in the West Riding of the county of York, comprised within the following boundaries, that is to say, commencing at a gate leading into a certain turnip field in the occupation of John Ripley situate at Tockwith Town End adjoining the York and Tockwith-road, thence running east to Wilstrop-lane End, thence up the said lane in a northerly direction to Mr. Brogden's fence near Syke drain, thence in a westerly and southerly direction alongside the said drain to the said York and Tockwith-road, and thence in an easterly direction to the gate aforesaid.

(3.) At Wentworth, in the West Riding of the county of York, comprised within the following boundaries, that is to say, commencing at the George and Dragon Inn Wentworth, through Wentworth village Church-lane to Ashcroft farm, thence by Hoodhill carriageroad to Haigh-lane, thence to Cawley-lane End, thence by Elsecar footpath to Elsecar Forge, and thence to Wentworth Mill by

Barrow to Wentworth.

(4.) So much of the township of Studley Roger, in the West Riding of the county of York, as lies within the following boundaries, that is to say, the boundary wall of Studley Park from the Park Lodge to Minns Cave and thence an imaginary line to the river Skell on, the west, the river Skell as far as the footbridge at Hell Wath and thence the Baron Way as far as the fence running westward to Škellbeck on the south and east, and the said fence and Skellbeck to the Park Lodge aforesaid on the north.

(5.) At Ossett-cum-Gawthorpe, in the West Riding of the county of York, comprised within the following boundaries, that is to say, commencing at the eastern boundary of Ossett township on the Wakefield and Halifax turnpike- road, following the said boundary in a northerly direction to New Park-lane, Low Lathes, and the footpath to Hollins Quarry, thence by a footpath to Lodge Hill and Town End to Nelly's Well, thence by a stream of township on the Wakefield and Halifax turnpike-road.

(6.) In the township of Burley, in the borough of Leeds, in the West Riding of the county of York, comprised within the following boundaries, that is to say, commencing in Burley-road at the point where the said road is crossed by the Burley Beck, thence proceeding along Burley-road aforesaid in an eastwardly direction to a point where the said road is crossed by the North-Eastern Railway, thence proceeding in a northwardly direction along the said Railway to a point where the said Railway is crossed by Cardigan-lane, and from thence along the east side of Burley Beck to a point where it crosses Burley-road aforesaid.

(7.) At Colton, in the West Riding of the county of York, comprised within the following boundaries, that is to say, commencing at Mrs. Kilby's house in the village of Colton and running east to Mr. Wilstrop's house in that village, thence northward by the boundary known as the Lazenby and Kilby's fence, thence westward by the said boundary to Stokers Garth, thence southward by the fence of the said Garth to Mrs. Kilby's house aforesaid.

(8.) At Blaxton, in the West Riding of the county of York, comprised within the following boundaries, that is to say, the River Torne on the north, the Gravel drain on the south, certain land in the occupation of George Terry on the west, and the highway leading from Finningley to Wroot on the east.

THE following Areas are now Areas Inferted with Swine-Fever under the above-mentioned Act (except the lines of railway within those Areas as far as those lines are used or required for the transit of swine through those Areas, without untrucking):-

Warwickshire.—In the borough of Birmingham, in the county of Warwick, comprised within the following boundaries, that is to say, Vauxhall-road on the north, Northumberland-street on the east, Saint James's-place on the west, and Viaduct-street on the south.

illshire.—The petty sessional divisions of Calne, Chippenham, and Malmesbury, in the county of Wilts.
