And whereas the Pilotage Board of Cardiff, being the Pilotage Authority for the Port of Cardiff, within the meaning of "The Merchant Shipping Act, 1854, have in exercise of the powers vested in them by that Act and by "The Bristol Channel Pilotage Act, 1861," from time to time made, and submitted for the consent of Her Majesty, certain Byelaws and Regulations which were approved by various Orders in Council:

And whereas the said Pilotage Board have made and submitted for the consent of Her Majesty certain new Byelaws and Regulations in lieu of the Byelaws and Regulations heretofore in force at the Port of Cardiff with respect to Pilots and Pilotage, and approved by various Orders in Council as aforesaid.

And whereas it has been made to appear to Her Majesty that the proposed new Byelaws and Regulations are proper and reasonable:

Now, therefore, Her Majesty, by virtue of the powers vested in Her by the said Merchant

of Her Privy Council, is pleased toapprove of and signify Her consent to the said new Byelaws and Regulations, as set forth in the Schedule hereto annexed, and to approve of their substitution from and after the date of this Order in Council for the Byelaws and Regulations heretofore in force with respect to the Pilots and Pilotage of the Cardiff Pilotage District.

BYELAWS made by the Cardiff Pilotage Board under Section 333 of "The Merchant Shipping Act, 1854.

1. Every Licensed Pilot employed in taking a Ship or Vessel between any Dock or Harbour in the Port of Cardiff, and any point in Cardiff Roads, or vice versâ, shall be paid according to the Registered Tonnage of such Vessel as follows:

4. Every Master, Owner, or Agent of any vessel navigating the Bristol Channel within the limits of this pilotage, who shall employ any un-

licensed person to act as, or perform the duty of Pilot-unless it be proved that no licensed Pilot could be obtained, or who shall retain such unlicensed Pilot on board to act as Pilot after a licensed Pilot shall have offered his services, shall be subject to a penalty of not exceeding fifty pounds for every such offence.

5. Except as provided by the 24th Section of "The Bristol Channel Pilotage Act, 1861," and as hereafter mentioned, no person shall be appointed to act as a Pilot unless he shall have served a regular apprenticeship for five years to a Channel Filot in the waters of the district aforesaid, and have been at least two years in square rigged sailing vessels; and no person shall be deemed eligible if less than 25 years or more than 45 years old. No person shall be bound apprentice to a Cardiff Pilot who shall be under the age of 14 years or over the age of 18 years, excep
