

other things, enacted that it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, from time to time to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to Her Majesty, with such advice as aforesaid, may seem fit:

And whereas Orders in Council have been made directing the discontinuance of burials in the churchyards hereinafter mentioned from the time specified in such Orders; and whereas it seems fit to Her Majesty, by and with the advice of Her Privy Council, that the time for discontinuing burials in the said churchyards be postponed:

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in such churchyards be postponed as follows, viz. :—

In the parish churchyard of North Frodingham, in the county of York, to the first day of July, one thousand eight hundred and eighty-three.

In the churchyard of Skirlaugh, in the county of York, to the thirtieth day of June, one thousand eight hundred and eighty-three.

In the parish churchyard of Coningsby, in the county of Lincoln, to the thirty-first day of March, one thousand eight hundred and eighty-four.

(FOOT-AND-MOUTH DISEASE.)

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The Area described in the Schedule to this Order is hereby declared to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the twenty-seventh day of April, one thousand eight hundred and eighty-three.

SCHEDULE.

An Area comprising such part of the township of Snape, or Snape-with-Thorp-and-Well-intermixed, in the North Riding of the county of York, as is comprised within the following boundaries, that is to say, the Bedale and Masham highway from Five-lane Ends northwards to the north-west corner of Roskill Plantation, thence the nearest line by hedgerow eastwards along the north side of Roskill Plantation and from the Plantation past Roskill farm buildings to the highway leading from Snape to Masham, then the last-mentioned highway south-westwards to Five-lane Ends aforesaid.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area (namely),—at Moulton Chapel, in the parish of Moulton, in the Parts of Holland, Lincolnshire, comprised within the following boundaries, that is to say, Garner's Dyke Bank alias Raven's Bank from the Guide Post in Moulton Chapel to the Old Mere drain on the south, thence the Old Mere drain to Whirl Gate on the west, thence Whirl Gate and along Fen Gate-road to the Old Engine Bank at Broad Water Bridge on the north, and thence the Old Engine Bank to the Guide Post in Moulton Chapel aforesaid on the east; exclusive of all boundary-roads but inclusive of all intersecting-roads,—which was declared by Order of Council dated the fourteenth day of March, one thousand eight hundred and eighty-three, to be an Area infected with foot-and-mouth disease, is hereby declared to be free from foot-and-mouth disease, and that Area shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the twenty-seventh day of April, one thousand eight hundred and eighty-three.
