(FOOT-AND-MOUTH DISEASE.)

AT the Council Chamber, Whitehall, the 11th day of May, 1883.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The following Area (namely),—so much of the township of Lathom, in the county of Lancaster, as lies within the following boundaries, that is to say, the river Douglas on the east and north, the river Tawd on the west, and the Leeds and Liverpool Canal on the south,—which was declared by Order of Council dated the tenth day of April, one thousand eight hundred and eighty-three, to be an Area infected with foot-and-mouth disease, is hereby declared to be free from foot-and-mouth disease, and that Area shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the twelfth day of May, one thousand eight hundred and eighty-three.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The following Area (namely),—so much of the parish of Westrill and Starmore, in the county of Leicester, as lies within the following boundaries, that is to say, on the north the road leading from Walcote to South Kilworth, on the south the road leading from Walcote to Stanford Hall, on the east the road from South Kilworth to Swinford, and on the west the road from Walcote to South Kilworth,—which was declared by Order of Council dated the fourteenth day of April, one thousand eight hundred and eighty-three, to be an Area infected with foot-and-mouth disease, is hereby declared to be free from foot-and-mouth disease, and that Area shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the twelfth day of May, one thousand eight hundred and eighty-three.
