THE FAIRS ACT, 1873. FULBOURN FEAST FAIR.

IN pursuance of the above-mentioned Act, I, the Right Honourable Sir William Vernon Harcourt, one of Her Majesty's Principal Secre-

taries of State, hereby notify as follows:

By Memorial, dated the 5th day of March, 1883, a representation has been duly made to me by the Justices of the Peace, acting in and for the Petty Sessional Division of Bottisham, in the county of Cambridge, that a Fair has been annually held at Fulbourn, in the said division of the said county, on the Monday, Tuesday, and Wednesday following the First Sunday after Trinity, and that it would be for the convenience and advantage of the public that the said Fair should be held on a less number of days than those on which such Fair is used to be held (to wit), on the Monday and Tuesday only following the First Sunday after Trinity:

2. On the 9th day of June, 1883, I shall take the aforesaid representation into consideration, and all persons are to intimate, before that day, any objection they may desire to offer to the said proposed alteration of the number of

days for holding the said Fair.

ORDER of the Local Government Board under the District Auditors Act, 1879: Assignment of District and Duties.

Sussex Audit District.

To John Thistlethwayte Rolt Allen, of North Bailey, in the County of Durham, District Auditor ;-

To the Guardians of the Poor of the several Unions and of the Separate Parish named in the Schedules to this Order ;-

To the Overseers of the Poor of the several Parishes comprised within the said Unions respectively, and of the said Separate Parish:

To the Overseers of the Poor of the Parish of Newtown, otherwise Saint John's, in the County of Sussex ;-

To the other Authorities referred to in Article 2 (Nos. 4 and 5) of this Order ;-

And to all others whom it may concern.

WHEREAS by Section 4 of "The District Auditors Act, 1879," it is enacted that the Local Government Board may from time to time assign to District Auditors their Duties, and the Districts in which such Auditors respectively are to act, and may from time to time change wholly or in

part such Duties or Districts;
And whereas the said John Thistlethwayte Rolt Allen is a District Auditor duly appointed under the provisions of the Statutes in that behalf, and is acting as Auditor for "The Northamptonshire

Audit District":

And whereas it is expedient that another District should be assigned to the said John Thistlethwayte Rolt Allen, in lieu of the District above-named:

Now therefore, We, the Local Government Board, hereby certify the appointment of the said John Thistlethwayte Rolt Allen as a District Auditor, and hereby Order and Prescribe as follows:-

ARTICLE 1.—The District in which the said John Thistlethwayte Rolt Allen shall, from the thirteenth day of May, one thousand eight hundred and eighty-three, act as Auditor, and which We hereby assign to him, shall, until We otherwise prescribe, comprise the area for the time being included in the several Unions named in the Schedule A., and in the Separate Parish and the other Parish named in the Schedule B. to this Order, and shall be termed "The Sussex Audit District."

ARTICLE 2.—It shall be the duty of the said District Auditor to audit the Accounts of the Officers; Authorities and their following namely,

(1.) The Guardians of the Poor of the said several Unions, and of the said Separate Parish.

(2.) The Overseers of the Poor of the several Parishes comprised in the said several Unions.

- (3.) The Overseers of the Poor of the said Separate Parish and of the said other Parish named in Schedule B. to this Order.
- (4.) The several other Authorities for the time being whose Accounts are cr may be by law subject to be audited by a District Auditor, and whose Districts or the areas of whose jurisdiction are for the time being wholly situated within the said Audit District.
- (5.) Such of the said other Authorities whose Accounts are or may be by law subject to be so audited, and whose Districts or the areas of whose jurisdiction are for the time being partly situated within the said Audit District, as We may by Order under Seal hereafter prescribe.

ARTICLE 3.—The said District Auditor shall audit the said Accounts according to the provisions of the several Statutes and of the Orders issued by competent authority, in force for the time being in that behalf, and shall perform all such duties and exercise all such powers in connection with the audit of such Accounts as are prescribed and conferred by the said Statutes and Orders.

ARTICLE 4.—In this Order-

The term "Union" includes any Union of Parishes incorporated or united for the relief or maintenance of the Poor under any Act of Parlia-

The term "Parish" includes any place for which a separate Poor Rate is or can be made or for which a separate Overseer is or can be ap-

The term "Guardians" includes any Governors, Directors, Acting Guardians, Vestrymen, or other Officers appointed or entitled to act in the distribution or ordering of relief to the Poor from the Poor Rates under any Act of Parliament.

The term "Overseers of the Poor" includes Churchwardens and Assistant Overseers.
