(FOOT-AND-MOUTH DISEASE.)

AT the Council Chamber, Whitehall, the 30th day of June, 1883.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The limits of the following Place which is declared by Order of the Local Authority for the county of Linlithgow, dated the fifteenth day of June, one thousand eight hundred and eighty-three, to be a Place infected with foot-and-mouth disease (namely),—the farm and lands of Dechmont, tenanted and occupied by William Mitchell, farmer there, and also the whole houses, courts, and sheds thereon as presently occupied by the said William Mitchell, and also that portion of the public-road or highway leading from Bathgate to Uphall which is situated between Chucket Hall Entry and Dechmont Old Toll, and also the whole portion of the parish of Livingstone which is situated on the north side of the said portion of the said road, and also the whole fields or enclosures which immediately adjoin the south fence of the said portion of the said road, the said whole subjects lying within the parish of Livingstone and county of Linlithgow,—are hereby extended so as to include the Place described in the Schedule to this Order, and the Place described in the Schedule to this Order (except the lines of railway within that Place as far as those lines are used or required for the transit of animals through that Place, without untrucking) is hereby declared to be a Place infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the first day of July, one thousand eight hundred and eighty-three.

SCHEDULE.

A Place comprising the farm and lands of Dechmont, tenanted and occupied by William Mitchell, farmer there, and also the whole houses, courts, and sheds thereon, and also that portion of the public-road leading from Bathgate to Uphall which is situated between Chucket Hall Entry in the parish of Livingstone and the point of junction in the parish of Uphall of the said road with the road leading by Uphall Kirk to Eccles-

machan, and also the whole portion of the parish of Livingstone which is situated on the north side of the said first-mentioned road, and also the whole fields or enclosures lying in the parish of Uphall which immediately adjoin the north fence of the said portion of the said first-mentioned road, and also the whole fields or enclosures in the parish of Livingstone which immediately adjoin the south fence of the said portion of the said road, the said whole subjects lying within the parishes of Livingstone and Uphall and county of Linlithgow.
