THE Board of Trade have received through the Secretary of State for Foreign Affairs the following copy of a Decree issued by the Republic of Honduras upon the subject of Navigation Patents, viz. :--

Office of the Secretary of State for Foreign Affairs, Tegucigalpa, January 1, 1883.

SEEING that during the administration of the former Governments, the Consular and Diplomatic Agents of the Republic gave, without any discrimination, Patents of Navigation to vessels of sundry nationalities, which, according to information received, still sail under the flag of Honduras; that the issue of Patents of Navigation has not even been officially communicated to the Government of Honduras, which is called upon to protect ships trading under the national flag; and that it is suitable to put an end to that vicious practice, which has given and may give room for the commission of abuses prejudicial to this country and to the interests of commerce; the President decrees:

1. From this date forward, Patents of Navigation can only be issued directly by the Government of the Republic, and consequently any that may be issued inadvertently by its Diplomatic or Consular Agents are invalid.

2. The space of one year is appointed in order that the owners or masters of ships holding Patents of Navigation issued by Diplomatic or Consular Agents may address themselves to the Government of the Republic, so that, if it consider fit, it may renew the said Patents in due form.

3. After the lapse of the aforesaid space of one year, the Patents of Navigation already issued by Diplomatic or Consular Agents of this Republic shall be altogether invalid; and

4. The office of the Secretary for Foreign Affairs shall communicate this Decree to all the Governments of the nations with whom the Government of this country is in correspondence, and further it shall take suitable measures that the said regulation may have the greatest publicity in the foreign press for the information of all persons who may have any interest therein.
