

The Bankruptcy Act, 1869.

In the County Court of Lancashire, holden at Liverpool.
In the Matter of John Harrison, of 16 and 18, Warwick-street, Liverpool, in the county of Lancaster, Timber Merchant, and residing at Borrowdale, Cressington, Aigburth, near Liverpool, a Bankrupt.

The bankrupt to pay to the Trustees, and the Trustees to accept on behalf of the creditors, a composition of 8s. in the pound upon the amount of their respective debts, by three equal instalments, payable respectively at the expiration of two, four, and six months from the date of the approval by the Court of the said scheme, the payment of this composition by such instalments to be secured by the promissory notes of the above-named bankrupt and two sureties, to be approved by the Committee of Inspection and the Trustee before the approval of the said scheme by the Court, such promissory notes to be given to the Trustee and held by him on behalf of the creditors; B. The property of the bankrupt to be held by the Trustee in trust to collect and get in the same and pay thereout all preferential claims, rent, taxes, possession, money, wages, and other outgoings since the adjudication and thenceforward to become due, owing, or payable in respect of the property of the bankrupt, and all costs and expenses of and incident to the bankruptcy, and of and incident to the said scheme, and to hold the residue until payment of the said composition as security therefor, with liberty from time to time, upon the request of the bankrupt, before any default shall have been made in payment of any instalment of the said composition and in case of default without any such request, to apply the whole or any part of such residue and the proceeds thereof in or towards payment of any unpaid instalment of the composition, and upon payment of the said composition to hold such residue or so much thereof as shall not have been applied to the purposes aforesaid, or any of them upon trust for the said bankrupt, his executors, administrators or assigns, to be paid or disposed of as he or they may direct; C. The bankrupt or the sureties to be at liberty to pay all or any of the said instalments in advance, deducting discount at the rate of five per cent. for the period elapsing between such payment and the due date of such instalments or instalment; D. Upon delivery of such promissory notes an order to be obtained annulling the adjudication and vesting the bankrupt's property in the Trustees upon the trusts hereby declared; 2. To consider and resolve upon all other resolutions and things necessary or expedient for effectuating and carrying out all or any of the above-mentioned objects or purposes, or with such variations or modifications thereof as the creditors may think expedient.—Dated this 11th day of July, 1883.
