WHEREAS the Lords of Her Majesty's Most Honourable Privy Council, in pursuance of the powers vested in them by an Act passed in the 6th year of the reign of His Majesty King George the IV, cap. 78, and by the Public Health (Scotland) Act, 1867, did, by an Order bearing date the 12th day of July, 1883, make certain Rules, Orders, and Regulations, and among these a Regulation to the following effect:—

"ART. VI. Every Local Authority within whose district persons are likely to be landed from any ship coming foreign shall, as speedily as practicable, with the approval of the Chief Officer of Customs of the Port, fix some place within the jurisdiction or district of the Local Authority where any ship may be moored or anchored for the purpose of Art. X, and shall make provision for the reception of Cholera patients and persons suffering from illness removed under Arts. XIII and XIV."

And whereas it has been represented to their Lordships that in some places there is no safe anchorage within the jurisdiction or district of the Local Authority.

Now therefore, the Lords of Her Majesty's Most Honourable Privy Council, by virtue of the powers in this behalf by the recited enactments or otherwise in them vested, do hereby order as follows:—

In the case of any district in which, in the opinion of the Local Authority, there is no place within the jurisdiction or district of such Local Authority where a ship may be safely moored or anchored, such Local Authority may for the purpose of Art. VI. of the said Order, fix some place without such jurisdiction or district, but as near thereto as possible, wherein a ship may be moored or anchored for the purpose of Art. X. of the said Order.

(FOOT-AND-MOUTH DISEASE.)

AT the Council Chamber, Whitehall, the 7th day of August, 1883.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area declared by Order of Council to be an Area infected with foot-and-mouth disease (namely),—the petty sessional

division of Elloe, in the Parts of Holland, Lincolnshire,—is, except such portions thereof as are included in the Areas described in Article 2 of this Order, hereby declared to be free from foot-and-mouth disease, and the Area above described, except as aforesaid, shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.

2. The following Areas (namely),—(1.) in the parish of Holbeach, (Holbeach Marsh,) in the petty sessional division of Elloe, in the Parts of Holland, Lincolnshire, comprising the whole of the Lapwater and Leadenhall farms, occupied by Mr. Joseph Ward, in Holbeach Marsh bordering upon Boston Deepes on the north; (2.) in the parish of Moulton, (Moulton Chapel,) in the petty sessional division of Elloe, in the Parts of Holland, Lincolnshire, comprised within the following boundaries, that is to say, the division line from Oxcroft Bank to Whaplode Bank between Mr. Fred Ward's and Mr. Henry Clark's farms on the south, Whaplode Bank on the east, and Oxcroft Bank on the west and north; (3.) in the parishes of Holbeach, and Fleet, (Holbeach Fen and Fleet Fen,) in the petty sessional division of Elloe, in the Parts of Holland, Lincolnshire, comprised within the following boundaries, that is to say, the highways from the first Railway Crossing east of Holbeach Railway-station up to Hurdle Tree Bank and thence along it to and along Holbeach St. John's-road up to Saturday Bridge on the west, thence Ravens Bank to Ravens Clough Public-house on the south, thence the direct highway to Fleet Church and Railway-station on the east, and thence the Railway Line to the above-named Crossing on the north; (4.) in the parishes of Holbeach, and Fleet, (Fleet Fen,) in the petty sessional division of Elloe, in the Parts of Holland, Lincolnshire, comprised within the following boundaries, that is to say, the Grass-lane from Holbeach St. John's Church direct to the Great South Holland drain on the west, the said drain to Decoy Bridge on the south, thence the highway to Jekylls, otherwise Jerkins, Bank on the east, and the said Bank up to the said Church on the north; (5.) in the parish of Whaplode, (Whaplode St. Catherine's,) in the petty sessional division of Elloe, in the Parts of Holland, Lincolnshire, comprised within the following boundaries, that is to say, Jekylls, otherwise Jerkins, Bank from Gelders Drove to Mill Gate on the south, Mill Gate to Mr. Charles Ashby's farmhouse on the east, an imaginary direct line across his farm to Gelders Drove on the north, and the said Drove up to the said Bank on the west; (6.) in the parish of Whaplode, (Whaplode Fen,) in the petty sessional division of Elloe, in the Parts of Holland, Lincolnshire, comprised within the following boundaries, that is to say, Flag-lane from Jekylls, otherwise Jerkins, Bank up to the Great South Holland drain on the west, the said drain to Pear Tree-lane on the south, the said lane to the said Bank on the east, and the said Bank to Flag-lane on the north; (7.) in the parishes of Weston, and Cowbit, (Weston Hills,) in the petty sessional division of Elloe, in the Parts of Holland, Lincolnshire, comprised within the following boundaries, that is to say, the southern side of Moulton Chapel-road on the north, Wheatmere drain on the west, the Great South Holland drain on the south, and an imaginary direct line from such Holland drain across Mr. Bryan Morris's lands to a Chase-road and along it to the said Moulton Chapel-road on the east; (8.) in the parish of Holbeach, (Holbeach Drove,) in the petty sessional division of Elloe, in the Parts of Holland, Lincolnshire, comprised within the following boundaries, that is to say,
