"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Cuthbert, Lorton, consisting of:—

"I. All that portion of the parochial chapelry of Lorton within the limits of the parish of Brigham in the county of Cumberland and in the diocese of Carlisle which is bounded on the south by an imaginary line commencing upon the boundary which divides the parochial chapelry of Loweswater within the limits of the parish of Saint Bees in the said county and diocese from the parochial chapelry of Lorton aforesaid at the point where the River Cocker is joined by Liza Beck and extending thence first eastward then south-eastward then north-eastward and then again south-eastward along the middle of the said beck for a distance of three miles or thereabouts to the point on the northern side of Eel Crag where the same beck approaches to within two chains of the boundary which divides the said parochial chapelry of Lorton from the new parish of Thornthwaite in the county and diocese aforesaid and extending thence that is from the last-described point eastward and in a direct line to the last-described boundary all which said hereinbefore described portion of the parochial chapelry of Lorton aforesaid is bounded upon the remaining sides other than upon the south as aforesaid that is to say upon the east upon the north and upon the west as follows upon the east by the new parish of Thornthwaite aforesaid upon the north by the parochial chapelry of Embleton within the limits of the parish of Brigham aforesaid and upon the west partly by the hereinafter described portion of the last-named parish and partly by the parochial chapelry of Loweswater aforesaid.

"II. All that detached and isolated portion of the chapelry of Buttermere within the limits of the parish of Brigham aforesaid which lies embedded within the hereinbefore described portion of the parochial chapelry of Lorton aforesaid and which contains by admeasurement one hundred and seventy acres or thereabouts and within which the houses called or known respectively as High Swinside and Low Swinside are situate.

"And III. All that portion of the parish of Brigham aforesaid which is contiguous to the hereinbefore described portion of the parochial chapelry of Lorton aforesaid and which consists of that part of the township of Whinfall which is not included within the limits of the district chapelry or new parish of Saint Philip Mosser in the county and diocese aforesaid."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Carlisle.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen, and of the Act of the seventeenth and eighteenth years of Her Majesty chapter eighty-four, duly prepared and laid before Her Majesty in Council a scheme, bearing date the second day of August, in the year one thousand eight hundred and eighty-three, in the words following, that is to say:—

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the third and fourth years of Your Majesty chapter one hundred and thirteen and of the Act of the seventeenth and eighteenth years of Your Majesty chapter eighty-four have prepared and now humbly lay before Your Majesty in Council the following scheme for apportioning the income of the benefice (being a parish and vicarage) of Hampton situate in the county of Middlesex and in the diocese of London between that benefice and the benefice (being a district parish and vicarage) of Hampton Wick situate in the said county of Middlesex and in the said diocese of London which said district parish of Hampton Wick was sometime part of the parish of Hampton.

"Whereas the whole advowson patronage and right of nomination and presentation of and to the said benefice of Hampton and also the whole advowson patronage and right of nomination and presentation of and to the said benefice of Hampton Wick is vested in Your Majesty Your heirs and successors in right of the Crown and the same is in the case of each of the said two benefices exercised on behalf of Your Majesty by the Lord High Chancellor of Great Britain.

"And whereas it has been made to appear to us that the said benefice of Hampton is at present so endowed as that after the apportionment hereinafter recommended and proposed shall have been made the same benefice will still be sufficiently endowed.

"And whereas the said benefice of Hampton Wick has at present no permanent endowment and no income other than income derived from pew rents and voluntary offerings and from fees.

"And whereas one part of the endowments of the said benefice of Hampton consists of certain lands and hereditaments situate in the parish of Mile End in the borough of Colchester in the county of Essex and of certain other lands and hereditaments situate in the same parish which said lands and hereditaments respectively are described in the schedule to this scheme annexed and are delineated and shown on the plan to this scheme also annexed.

"And whereas the Right Honourable Roundell Earl Selborne now Lord High Chancellor of Great Britain has represented to us and we are of opinion that it is desirable that additional provision should be made for the cure of souls within the district parish of Hampton Wick aforesaid by means of that immediate apportionment of the income of the said benefice of Hampton which is hereinafter recommended and proposed.

"And whereas the Reverend Robert Digby Ram now vicar or incumbent of the said parish of Hampton is willing that the same immediate apportionment shall be effected accordingly and in testimony of such his willingness has executed this scheme in manner hereinafter mentioned.
