Reverend John Bishop of London acting as Bishop of the said diocese of London and with the consent of the said Roundell Earl of Selborne as the patron on behalf of Your Majesty as aforesaid of each of the said two benefices as aforesaid and with the consent of the said Robert Digby Ram vicar or incumbent of the said benefice of Hampton (in testimony whereof the said John Bishop of London has signed this scheme and sealed the same with his episcopal seal and the said Roundell Earl Selborne has signed this scheme and sealed the same with his seal and the said Robert Digby Ram has also signed and sealed this scheme) we the said Ecclesiastical Commissioners humbly recommend and propose that without any conveyance or assurance in the law other than this scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and as from the day on which such Order shall be published in the London Gazette, the lands and hereditaments situate in the said parish of Mile End in the borough of Colchester in the said county of Essex which are respectively here-inbefore referred to and are mentioned and described in the schedule to this scheme annexed and which are shown and delineated on the plan to this scheme also annexed and are on the same plan coloured pink shall be conveyed and transferred from the said benefice of Hampton and from the vicar or incumbent thereof and from his successors to the said benefice of Hampton Wick and to the vicar or incumbent thereof and to his successors so that the same lands and hereditaments and every part thereof shall thenceforth become and be absolutely vested in the vicar or incumbent for the time being of the said benefice of Hampton Wick and his successors as part of the endowments of the same benefice and so that he and they as owners thereof respectively shall have and enjoy all the rights powers and privileges in respect thereof respectively which are now or might hereafter be enjoyed by the vicar or incumbent of the said benefice of Hampton and his successors.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme has reference.

"Description of farm lands &c. in the county of Essex proposed to be annexed to the benefice of Hampton Wick.

"First. All that farm with the farmhouse and appurtenances known as Upper Braiswick Farm containing in the whole one hundred and twenty acres and six perches or thereabouts situate in the parish of Mile End in the borough of Colchester in the county of Essex.

"Secondly. All those two plots of land forming part of the farm known as Chapman's Farm situate in the parish of Mile End aforesaid together containing twenty-one acres one rood and eight perches or thereabouts.

"And all which said premises first and secondly above described are delineated on the plan annexed to this scheme and are thereon coloured pink."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council. is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately

from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts ; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirty-third and thirty-fourth years of Her Majesty chapter thirty-nine, and of the Acts therein recited, that is to say, the Act of the third and fourth years of Her Majesty chapter one hundred and thirteen, the Act of the fourth and fifth years of Her Majesty chapter thirty-nine, and the Act of the thirty-first and thirtysecond years of Her Majesty chapter one hundred and fourteen duly prepared and laid before Her Majesty in Council a scheme, bearing date the second day of August, in the year one thousand eight hundred and eighty-three, in the words following, that is to say :-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the thirtythird and thirty fourth years of Your Majesty chapter thirty-nine and of the Acts therein recited that is to say the Act of the third and fourth years of Your Majesty chapter one hundred and thirteen the Act of the fourth and fifth years of Your Majesty chapter thirty-nine and the Act of the thirty-first and thirty-second years of Your Majesty chapter one hundred and fourteev, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and benefice of Llanfairis-Gaer which church and benefice are situate in the county of Carnarvon and in the diocese of

Bangor. "Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Llanfair-is-Gaer and to the church thereof is now vested in the Bishop of Bangor and his successors.

"And whereas George William Duff Assheton Smith of Vaynol in the county of Carnarvon Esquire has made to our satisfaction a certain benefaction in favour of the said benefice of Llanfair-is-Gaer: to wit a sum of one thousand six hundred and sixty-six pounds thirteen shillings and four pence three pounds per centum Consolidated Bank Annuities ; which sum has been transferred to us by the said George William Duff Assheton Smith upon the understanding and condition that a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the same benefice and the church thereof from the Bishop of Bangor and his successors (in whom the same right of patronage is now vested as aforesaid) to the said George William Duff Assheton Smith and his heirs and assigns shall be effected by the agency of us the said Ecclesiastical Commissioners for England.

"And whereas the Right Reverend James Colquhoun now Bishop of Bangor, is willing for himself and his successors to transfer to the said George William Duff Assheton Smith and his heirs and assigns the said advowson or perpetual right of patronage of and presentation to the said benefice of Llanfair-is-Gaer and the church
