

(2.) The whole of the parish of Eggleton, in the county of Rutland.

(3.) The whole of the parish of Whissendine, in the county of Rutland.

(4.) The whole of the parishes or places of Pilton, Wing, Preston, Martinthorpe, and Gunthorpe, in the county of Rutland, and so much of the parish of Manton in the said county as lies on the west side of the old turnpike-road leading from Oakham to Uppingham and the said old turnpike-road.

(5.) The whole of the parish of Hambleton, in the county of Rutland, and so much of the parish of Edith Weston as lies on the west side of the road leading from the South Gate into Normanton Park to a house occupied by Colonel Jones on the road leading to Manton in the said county and as lies on the north side of the said road leading to Manton aforesaid.

(6.) The whole of the parish of Brooke, in the county of Rutland.

(7.) The whole of the parish of Belton, in the county of Rutland.

(8.) Such part of the parish of Burley-on-the-Hill, in the county of Rutland, as lies on the south side of the road leading from Oakham through the village of Burley-on-the-Hill to the Old Toll Bar and from thence by the Park Wall to the boundary of the parish of Exton.

(9.) The whole of the parish of Tickencote, in the county of Rutland.

Shropshire.—All that portion of the county of Salop situated to the north or north-east of the following boundary road, namely,—the road running from Ightfield by Calverhall to Bletchley, and thence to Rose Hill, and thence by Colehurst and Sutton to the boundary of the county at Four Alls.

Surrey.—(1.) The parishes of Egham, Thorpe, and Chertsey, in the county of Surrey.

(2.) In the borough of Reigate, comprised within the following boundaries, that is to say, the London and Brighton Railway towards the east, the road leading from Mill-street to Linkfield-street and thence to Hatchlands towards the north, the western boundary of Redhill and Earlswood Commons towards the west, and the borough boundary towards the south.

(3.) So much of the borough of Reigate and of the county of Surrey as lies within the following boundaries, that is to say, the London and Brighton Railway towards the west, by Honeycrock-lane, Mason's Bridge-lane, and the lane leading from Shocks Green to Kings farm to the south, and thence along Clay-lane to the South-Eastern Railway, and the South-Eastern Railway on the north.

Sussex.—(1.) At Ticehurst, in the county of Sussex, comprised within the following boundaries, that is to say, commencing at a point at the north corner of Church Settle-lane where it joins the Stonegate-road and continuing along such lane towards the west to the South-Eastern Railway, thence following the line of such Railway to the Bridge over such Railway, and from thence along the parish-road through Stonegate up to the south end of a bridle-road at the eastern end of Bardown farm and proceeding along the northern boundary of such farm, and from thence along the northern boundary of Bolsters Gate farm up to the said parish-road, and from thence along such road up to the said north corner of the said Church Settle-lane.

(2.) So much of the county of Sussex as is comprised within the following boundary, that

is to say, from the White Ditch by Broad Wall to Horseye Bridge, from Horseye Bridge by the highroad to Rickney, from Rickney by the highroad to Chilly, from Chilly by the highroad to Broadwater in Pevensy, thence by the Haven to Does Corner, thence by the Haven to Wartling Hill, thence by the boundary of the Pevensy Marsh to Herstmonceux, thence by the road to Newbridge, thence by the road known as the Marshfoot Wall to the boundary of the said Marsh, and thence by the boundary of the said Marsh to White Ditch aforesaid.

Warwickshire.—The parishes of Ashow, Kenilworth, Milverton, Leek-Wootton, Stoneleigh, and Honiley, in the county of Warwick.

Yorkshire (West Riding).—The whole of the Rotherham District of the Upper Strathforth and Tickhill petty sessional division in the West Riding of the county of York.

(SWINE-FEVER.)

THE following Areas are now *Areas Infected with Swine-Fever* under the above-mentioned Act (except the lines of railway within those Areas as far as those lines are used or required for the transit of swine through those Areas, without untrucking):—

Berkshire.—(1.) The whole of the parish of Frilford, in the county of Berks.

(2.) The whole of the parish of Garford, in the county of Berks.

(3.) The whole of the parish of Sutton Courtney, in the county of Berks.

Buckinghamshire.—(1.) The whole space in the hamlet of Walton and township of Aylesbury, in the county of Buckingham, lying between the Tring-road, the Walton-road, Walton-street, and Exchange-street, and also the whole of the said Walton-road, and so much of the said Walton-street as leads from the said Walton-road to the said Exchange-street.

(2.) The whole of the parish of Edlesborough, in the county of Buckingham.

Wiltshire.—The petty sessional divisions of Calne, Chippenham, and Malmesbury, in the county of Wilts.
