east by the outer boundary of the road from Dauntsey to Brinkworth, on the south by the Brinkworth brook, and on the west by a straight line drawn from the said brook to the said mainroad,-which were declared by Order of Council to be Areas infected with swine-fever, are hereby declared to be free from swine-fever, and those Areas shall, as from the commencement of this Order, cease to be Areas infected with swinefever.

2. This Order shall take effect from and immediately after the fifteenth day of November, one thousand eight hundred and eighty-three.
