In Parliament.—Session 1884. Leeds Corporation.

(New Street and Street Improvements; Compulsory Purchase of Lands and of Coloured Cloth Hall; Provisions relating thereto; Amendment of Section 92 of the Lands Clauses Consolidation Act, 1845; Provisions as to Sale of Surplus Park and other Lands; Creation of an Insurance Fund; Suppression of Street Betting; Protection of Sources of Water-Supply and Preventing Polution thereof; Payment of Expenses of Bill; Further Money Powers; Incorporation of Acts; Amendment of Acts, and other purposes).

OTICE is hereby given, that application is intended to be made to Parliament, in the ensuing session, by the Mayor, Aldermen, and Burgesses of the borough of Leeds (who are in this notice referred to as "the Corporation"), for leave to bring in a Bill (in this notice called "the Bill") for the following or some of the following among other objects, powers, and purposes, that

is to say:

1. To enable the Corporation to make and maintain the following or some of the following new street and widenings and improvements of streets, and other improvements and works, all in the township, parish, and borough of Leeds, in the West Riding of the county of York, namely :

New Street and Street Improvements.

A new street commencing in the centre of Park-row, opposite the south-eastern corner of the General Post-office, crossing Infirmary-street, passing through the Coloured Cloth Hall, crossing Quebec-street, and terminating at or near the centre of Airestreet at its junction with Wellington-street.

B. The widening and improvement of the south-western side of Infirmary-street, such widening and improvement commencing at a point in that side 20 yards or thereabouts southward from and in a line with the eastern side of Wine-street at its junction with Infirmary-street, and terminating at a point on the south-western side of Infirmary-street 42 yards or thereabouts northwestward from the junction of that side with Park-row.

C. The widening and improvement of the north-east side of Quebec-street, such widening and improvement commencing and terminating respectively at points in that side 68 yards or thereabouts and 40 yards or thereabouts respectively, measured in a north-westwardly direction, from the junction of that side with Wellington-street.

D. The widening and improvement of the south-west side of Quebec-street, such widening and improvement commencing and terminating respectively at points in that side 52 yards or thereabouts and 262 yards or thereabouts respectively, measured in a north-westwardly direction, from the junction of that side with Wellingtonstreet.

E. The widening and improvement of the north side of Wellington-street, such widening and improvement commencing and terminating respectively at points in that side 109 yards or thereabouts and 38 yards or thereabouts respectively, measured in a westwardly direction, from the junction of that side with Quebec-street.

F. The widening and improvement of the south-east side of Aire-street, such widening and improvement commencing at the junction of that side with the south side of Clauses Consolidation Act, 1845.

Wellington-street, and terminating at a point in that side 30 yards or thereabouts, measured in a south-westwardly direction, from the junction of that side with Wellington-street.

G. In connection with such new street and street improvements the formation of a square or other open space within the following boundary, that is to say:-A boundary commencing in Park-row at a point opposite the south-eastern corner of the General Post-office, continuing thence in a southwardly direction along Park-row to its junction with the north side of Wellington-street, continuing thence in a westwardly direction along the north side of Wellington-street to a point in that side opposite, or nearly opposite, to the junction of Aire-street with Wellington-street, continuing thence in a north-eastwardly direction along an imaginary straight line being the line of the intended new street to the point of the commencement of the boundary in Park-row, and to stop up and appropriate for the purposes of such square or open space all or any part of the streets, roads, lanes, passages, and other places situate in the lands included within the said boundary.

2. To authorise the Corporation to deviate in the construction of the said new street and other works laterally within the limits to be shown upon the plans hereinafter mentioned, and to deviate vertically from the levels of the works shown upon the sections hereinafter mentioned to any extent to be authorised by the

3. To authorise and empower the Corporation to purchase by compulsion or agreement lands, houses, and other property (and particularly the building known as the Coloured Cloth Hall, and all lands, hereditaments, rights, privileges, and appurtenances belonging to or connected therewith), in the township and parish aforesaid, for the purposes of the before-mentioned new street and other works, and for the purpose of the improvement of streets and the erection of suitable houses and other buildings in streets to be constructed, improved, or widened under the powers of the Bill; or under any power already possessed by the Corporation, and for other the purposes of the Bill; and to vary or extinguish all rights and privileges over or affecting or in any manner connected with the lands, houses, and other property to be purchased or taken.

4. To enable the Corporation from time to time to demise, sell, lease, exchange, or otherwise dispose of the lands, houses, buildings, and other hereditaments purchased or to be purchased or acquired by them under the powers of the Bill, or any part thereof, for the erection thereon of houses and other buildings, and for such other

purposes as the Bill may define.

5. To make provision (if requisite) for the assessment or ascertaining of the amount of compensation to be given or paid to the various owners of or other persons (if any) interested in the said Coloured Cloth Hall, and to make such other provisions with respect thereto or to the purchase or taking of the said Hall as the Bill

may provide or Parliament sanction.
6. To enable the Corporation to purchase so much of any house or other building or manufactory or other property to be purchased or taken under the powers of or for the purposes of the Bill without being subjected to the liability imposed by the 92nd section of the Lands
