the objects thereof, and to confer, vary, and

extinguish other rights and privileges.

To authorise the crossing, stopping-up, altering, or diverting, whether temporarily or permanently of all public carriage and other roads, highways, railways; tramways, canals, fivers, streams, drains, sewers, pipes, and telepraphic and telephonic wires, and apparatus within or adjoining to the before-mentioned parishes, townships, and other places which it may be necessary or convenient to cross, stop-up, alter, or divert in executing the several purposes of the intended Act; and the said Act will provide for the stopping-up and extinguishment of all rights of way in and over, and for the vesting in and appropriation by the two Companies, or one of them, of the site and soil of all roads or ways intersecting or being upon the lands to be acquired under the powers of the intended Act.

To empower the two Companies, or either of them, to demand and recover tolls, rates, and charges for or in respect of the use of the works authorised by the intended Act, or some of them, and to alter existing tolls, rates, and charges, and to grant exemptions from the payment of tolls,

rates, and charges.

To empower each of the two Companies for all or any of the purposes of the intended Act, and for other the general purposes of the Preston and Wyre Railway Undertaking, to increase their capital and to raise further sums of money by the creation and issue of new shares or stock, with or without a guaranteed or preference dividend,

or other rights or privileges attached thereto, and by the creation and issue of debenture stock and by borrowing or by any of such of means, and also to apply to all or any of such purposes, any capital or funds belonging to each of the two Companies.

For the purposes aforesaid it is intended, if need be, to alter, amend, and extend, or to repeal all or some of the powers and provisions of the local and personal Acts following, or some of them (that is to say):—The Act 22 and 23 Vic., cap. 110, and all other Acts relating to the Lancashire and Yorkshire Railway Company; the Act 9 and 10 Vic., cap. 204, and all other Acts relating to the London and North Western Railway Company; the Act 5 and 6 William IV., cap. 58, and all other Acts relating to the Preston and Wyre Railway Harbour and Dock Com-

pany.
