The Bill will alter, amend, enlarge, or repeal, so far as necessary, the Southampton Cemetery Act, 1843, and the Southampton Marsh and Markets Acts, 1844 and 1865, and also the Southampton Improvement Act, 1844, 7 and 8 Vict., chap. 75, and any other Acts relating to or affecting the Corporation or the borough of Southampton; and it will incorporate with itself the necessary provisions of the Cemeteries Clauses Act, 1847, the Lands Clauses Consolidation Acts, 1845, 1860, and 1869, and of any other Act or Acts amending or varying those Acts respectively.

On or before the 30th day of November, 1883, plans of the lands intended to be purchased for the cemetery and for the other purposes of the Bill, with a book of reference thereto, and a copy of this notice, as published in the London Gazette, will be deposited with the Clerk of the Peace for the county of Southampton, at his office in Winchester, with the Clerk of the Peace for the town and county of the town of Southampton, at his office in Southampton, and with the Town Clerk of the borough of Southampton, at his office in Southampton, and with the parish clerk of the parish of Saint Mary, at his residence.

Frome Gas.

(Application to the Board of Trade, under The "Gas and Water Works Facilities Act, 1870," for a Provisional Order, Authorising the Construction of New Gas Works; Increase of Capital; Purchase of Gas Engines, &c.; Incorporation and Amendment of Acts.)

**N**OTICE is hereby given, that the Frome Gas Company (hereinafter called "the Company") intend to apply to the Board of Trade, under "The Gas and Water Works Facilities Act, 1870," for a Provisional Order, to be confirmed by Parliament in the ensuing Session, for the following purposes, or some of them, that is to say:—

To empower the Company to erect, make, and maintain additional buildings, works, apparatus, machinery, and conveniences for the manufacture and storage of gas and any residual products arising in or from the manufacture of gas, and to manufacture and store gas and residual products on certain land already acquired and now belonging to the Company, that is to say, on all that piece of pasture or garden land situate at Welshmill, in the parish of Frome Selwood, in the county of Somerset, containing one acre and a quarter, or thereabouts, bounded on the north by the River Frome and by land belonging to the Earl of Cork, on the south partly by Welshmill-lane, and partly by other land belonging to

the Company, on the west by the works of the Company, and on the east by land belonging to the Earl of Cork.

And to empower the Company for the general purposes of their undertaking, to acquire and hold other lands by agreement, and to enable them to sell and dispose of lands.

To enable the Company to raise additional capital by shares or stock, and by borrowing, subject to all such shares or stock being sold by auction or by tender, with power to issue any new shares or stock, with a preference or priority of dividend, and upon such terms and conditions as may be prescribed in the Provisional Order.

To fix and regulate the capital of the Company, and to authorise and empower the Company to create and issue debenture stock.

To vary and extinguish all existing rights and privileges which would interfere with the use of the land in manner hereinbefore set forth, or would otherwise interfere with the object or purposes of the intended Order.

To enable the Company to purchase, sell, rent, let, hire, or otherwise deal in gas engines, stoves, heating or cooking apparatus, and with all requisite fittings, machinery, and conveniences for fixing or using the same, and whether for public or private purposes, and apparatus and conveniences for the making, storing, consuming, or otherwise disposing of or using residual products arising in the making or purifying of gas, and if requisite to alter or adapt for any of the aforesaid purposes, the mains, pipes, machinery, works, and plant of the Company, and to make applicable to such purposes all or any of the powers vested in the Company under their Act of Parliament.

To incorporate with the intended Order, so far as the same are applicable, and with or without alteration, all or some of the provisions of "The Companies Clauses Consolidation Act, 1845," "The Companies Clauses Act, 1863," "The Companies Clauses Act, 1869," "The Gasworks Clauses Act, 1847," and "The Gasworks Clauses Act, 1871;" to amend and enlarge the provisions of "The Frome Gas Act, 1866," and to confer upon the Company all such other powers, rights, and privileges as may be necessary or expedient for the purposes of their undertaking and for carrying into effect the purposes of the intended Order.

On or before the 30th day of November, 1883, a copy of this notice or advertisement, a map showing the lands to be used in the manufacture and storage of gas, and a plan of the existing and proposed gasworks, will be deposited for public inspection with the Clerk of the Peace for the county of Somerset, at his office at Wells, in the said county, and also at the office of the Board of Trade, Whitehall, London.
