respectively, and for securing the preservation of the property of the Corporation therein. 21. To empower the Corporation to construct

and maintain in the parks and recreation grounds, swimming baths, bowling greens, gymnasiums, lavatories, and water-closets, with all requisite appliances, and to provide apparatus and appliances for games, and to charge for the use of the same respectively, and to make and enforce bye-laws for regulating the times, conditions, and payments for the user thereof, and the conduct of persons frequenting the same, and for the preservation thereof, and of the property therein.

22. To authorise the Corporation to make and enforce bye-laws, rules, and regulations with respect to their Cemeteries and Burial Grounds, for regulating the days, hours, and conditions of admission thereto, and exclusion therefrom, and the conduct of persons frequenting the same, and for excluding therefrom persons not connected with any funeral thereat, and for protecting the property whether of the Corporation or of others therein.

23. To make provision with respect to fire police and fire brigades, the entering of premises on fire, and to extend the provisions of Section 33 of the "Town Police Clauses Act, 1847," to fires within the borough.

24. To regulate and license brokers, hawkers of marketable goods, pawnbrokers, scavengers, lodging houses, marine store dealers, places for music, dancing, games, and public entertainment, porters, drovers, hackney carriages, carts, and animals plying for hire, and their drivers and attendants.

25. To enable the Corporation to provide and maintain or permit the providing and maintenance in public thoroughfares of places of shelter and convenience for the use of drivers and conductors of hackney carriages and public conveyances and of licensed porters, public water-closets, urinals, and lavatories, and to make and enforce bye-laws and regulations for and in relation to the premises, and the persons using or resorting to the same respectively, and to make and recover charges for the user thereof.

26. To prohibit the fixing, placing, or attaching of any wire, tube, or other apparatus for telegra-phic, telephonic, or electrical purposes over any street, road, or public thoroughfare, except with the consent of the Corporation, and on such terms and conditions as they shall deem expedient to prevent obstruction, danger, or annoyance to the traffic, or to passengers therein, and to empower the Corporation to inspect any such tube, wire, or apparatus (whether existing or future), and the supports and attachments thereof, and to order the repair, alteration, renewal, or removal thereof respectively, and in default thereof to enable the Corporation to execute the requisite works themselves at the cost of the owner or hirer thereof, and to exercise all such powers of entry on premises as may be necessary for the purposes afore-said, and to relieve the Corporation from all liability by reason of any failure of, or accident from, any such wire, tube, apparatus, or works.

27. To make further provision with respect to street traffic, and the regulation thereof, by the Mayor, the Corporation, and police.

28. To empower the Corporation to regulate the use of traction engines in the borough, and to make bye-laws with respect thereto, as though it were a borough having a Court of Quarter Sessions.

29. To make further provision with respect to matters of police within the borough, and especially to enable the Corporation to appoint parkkeepers and market officers special constables therein; to charge for special services of the

police; to enter unlicensed theatres and buildings used for dramatic entertainments; to prohibit the alteration of, and addition to, licensed premises; control over retail coal sellers, bicycles, and dogs.

30. To prohibit the casual employment of children in streets and other public places.

31. To authorise the Corporation to charge owners of property with the costs of altering, forming, paving, flagging, levelling, sewering, draining, channelling, kerbing, and making good of streets, roads, and footways adjoining their property, and of maintaining occupation roads, bridges, and footways, and of the execution of works by the Corporation in default of such owners, and to provide for the apportioning and charging of such costs on such property, and generally for the apportioning; charging, and recovering of such costs and of expenses known as "New Street Expenses" or "Private Improvement Expenses," and to enable the Corporation to apply the General District Rate to the defraying of such costs and expenses, and to borrow money therefor and to enable owners with limited interests to charge their property with any such costs and expenses payable by them.

32. To authorise the Corporation to acquire, and if need be by compulsion, the fee of all or any leasehold lands now held by them (and especially of the site of the present market of the Corporation), or which they may acquire for the purposes of the Bill; and to enable them to accept grants of and to hold land for any of the purposes of the Bill.

33. To enable the Corporation for all or any of the purposes of the Bill to appropriate any lands now vested in them, and to purchase or otherwise acquire, compulsorily or by agreement, lands, buildings, easements and other property, and to vary and extinguish all rights of way, manorial and other rights, conditions and covenants thereover, and particularly to purchase or otherwise acquire the following for market purposes :-

- Certain lands, with buildings thereon, situate in the township and parish of Dewsbury, on the north side of New Bridge-street, bounded on the north-west by certain land laid out as a new street, leading from Cloth Hall-street to the Beck, on the north-east by the Beck, on the east by Crackenedge-lane, and on the south by New Bridge-street.
- Certain lands and buildings in the said township and parish of Dewsbury, on the south side of New Bridge-street, bounded on the north by that street, on the east by Crackenedge-lane, on the west by Foundry-street, and on the south by a warehouse, abutting on the market-place, belonging or reputed to belong to Mr. Richard Oldroyd Clay.

34. To authorise the Corporation to stop up, divert, either temporarily or permanently, wholly or partially, appropriate, use, and arch over any street, court, road, bridge, footpath, stream, watercourse, navigation, railway, tramway, or passage and to remove and alter sewers, drains, pipes, and telegraph, telephone and other electric wires, where necessary or expedient, in carrying into execution the various powers of the Bill, and particularly to stop up and extinguish all rights of way or other public rights in or over or in connection therewith, and to appropriate the site and soil of so much of New Bridge-street as extends from its junction with Foundry-street to its ter mination in Crackenedge-lane.

35. To enable the Corporation to accept and hold lands for charitable or public purposes, and to accept and hold grants of money in respect thereof.
