called "the borough"), in the county of Durham (hereinafter called "the Corporation"), being also the urban sanitary authority of that borough, for an Act to effect the following, or some of the following, among other purposes (that is to say):—

To authorise the Corporation to make, widen, and maintain the footbridge, bridge, and works hereinafter described, or some part or parts thereof, with all needful works, approaches, and conveniences connected therewith respectively

(that is to say):—

(1.) A footbridge over the North Eastern Railway at or near the site of the existing footbridge over that railway belonging or reputed to belong to the North Eastern Railway Company, commencing on land belonging or reputed to belong to that Company, at or near the main entrance to the Jarrow Railway Station, and terminating on land belonging or reputed to belong to the said Railway Company at the north side of Grant-street, at or near the junction of that street with Railway-street.

(2.) To widen on each side thereof to the extent of seven feet or thereabouts an existing bridge belonging or reputed to belong to the North Eastern Railway Company, called or known as Monkton-road Bridge, carrying Monkton-road over the North Eastern Rail-

way

The said bridges and works will be wholly situate within the county of Durham, and will pass from, in, through, or into, or be situate within the parishes, townships, and extra-parochial and other places following, or some of them (that is to say), the township of Hedworth, Monkton, and Jarrow, and parish of Jarrow.

To purchase by compulsion or agreement, lands, houses, and property, for the beforementioned works, or any of them, and also to purchase by compulsion or agreement all or some of the lands, quays, houses, and buildings, situate in the township of Hedworth, Monkton, and Jarrow, and parish of Jarrow, within the boundaries of the pieces of land hereinafter described (that is to say):—

(1.) A piece of land called or known as the Jarrow Corporation Quay, bounded on the north by the River Tyne, on the south by Tyne-street, on the west by the works of the Palmer Shipbuilding and Iron Company, Limited, and on the east by land belonging or reputed to belong to the South Shields

Gas Company.

(2.) A piece of land bounded on the north by the River Tyne, on the south by a road leading from the 'east end of Tyne-street to the Curlew, on the west by the works of the Jarrow Forge Company; and on the east by land belonging or reputed to belong to Mrs. Isabella Drewett, and agreed to be leased to Messrs. Gavin, Smith, and Com-

(3.) A piece of land bounded on the north by the River Tyne, on the south by the road leading from the east end of Tyne-street to Jarrow Quay corner, on the west by the chemical works of Messrs. Richardson and Company, and on the east by the works of the Jarrow Cement Company, Limited.

To break up and also to stop up, alter, divert, and interfere with, either temporarily or permanently, and to cross over, under, or upon all such streets, roads, highways, bridges, thoroughfares, railways, tramways, rivers, streams, brooks, watercourses, sewers, drains, gas and water pipes, telephone and telegraph apparatus, as it may be

necessary or convenient to break up, stop up, alter, divert, interfere with, or cross for any of the purposes of the intended Act; and to extinguish all rights of way and other rights in, over, or upon any lands to be acquired under the powers of the intended Act.

To acquire by agreement or exchange a piece of land belonging or reputed to belong to the South Shields Gas Company, and bounded on the north by the River Tyne, on the south by Tyne-street, on the west by the quay leased to and in the occupation of the Corporation of Jarrow, and on the east by the works of the Jarrow Forge Company.

To enter into and carry into effect any agreements, and to confirm any agreements which may have been entered into by the Corporation for or relating to the acquisition of any lands or carrying out any of the purposes of the intended

Act.

To empower the Corporation to erect warehouses, cranes, and other machinery on lands acquired or to be acquired by them, and to levy tolls, rates, and dues for the use of the same.

To extend and also to make further provisions as to the working, maintenance, regulation, and management of the ferries for the transport by steam power or otherwise of passengers, horses, carts, carriages, and other vehicles, from the borough to the opposite bank of the River Tyne.

To make new and further provisions, and to confer additional powers on the Corporation, or to confirm all or any of their existing powers with respect to all or any of the matters herein-

after mentioned (that is to say) :-

To provide for the levelling, paving, flagging, metalling, lighting, channelling, sewering, and draining, and making good of private streets and footways, and the charging and recovery of the expense thereof on and from the owners thereof, and to give additional powers to the Corporation for recovery of the same by sale or possession of such premises.

To provide that successive owners of lands, houses, or other property, for, or in respect of which any expenses have been incurred by the Corporation, shall be liable to the Corporation for repayment of the same.

To enable the Corporation to recover from the owners of places in which public worship has been discontinued after such places have been converted into business premises or dwelling houses, or ceased to be used for public worship, or for the purpose for which they were originally appropriated, the amount of expenses incurred by the Corporation, or originally expended by the Corporation or by their predecessors.

To define or extend the definition of the terms "infectious or contagious disease"

and "house."

To make provisions and regulations with respect to the prevention and spread of infectious and contagious diseases.

To make provisions as to persons ceasing to occupy premises in which infectious diseases have existed without previous disinfection, or giving notice.

To provide for notice of persons suffering from infectious or contagious diseases being given of the nature of such diseases by the medical attendant or other person to the Corporation, or to the medical officer of

health or inspector of nuisances.

To make furthur and better provisions for the proper and sufficient ventilation, drainage,
