To authorise the Company to apply their corporate funds and revenues for all or any of the purposes of the Bill.

To vary or extinguish all rights and privileges inconsistent with, or that may in any way interfere with, any of the objects of the Bill, and to confer other rights and privileges.

To incorporate, extend, and make applicable to the purposes of the Bill all or some of the powers and provisions of "The Lands Clauses Consolidation Acts, 1845, 1860, and 1869," except the provisions of those Acts with respect to the purchase and taking of lands otherwise than by agreement, and with respect to the entry upon lands by the Promoters of the Undertaking, and "The Waterworks Clauses Acts, 1847 and 1863," and all other Acts amending or extending those Acts, or any of the provisions thereof.

To alter, amend, and repeal, so far as may be necessary or expedient for any of the purposes of the Bill, all or some of the provisions of the several Acts following, or some of them, that is to say: "The Southwark and Vauxhall Water Act, 1852," and all other Acts relating to the Company; 46 Geo. 3rd, Cap. 119, and all other Acts relating to the Company of Proprietors of the West Middlesex Waterworks; 11 and 12 Vict. Cap. 7, and all other Acts relating to the Company of Proprietors of Lambeth Waterworks; 49 Geo. 3rd, Cap. 189, and all other Acts relating to the Company of Proprietors of the Kent Waterworks; the Act local and personal 5 and 6 Wm. 4th, Cap. 81, and also any other local and personal Acts which it may be necessary to alter, amend, or repeal, for any of the purposes of the Bill, and the Bill will further alter, and, if need be, repeal "The Metropolis Water Act, 1852," and "The Metropolis Water Act, 1871," or certain parts of those respective Acts.

Ruthin and Cerrigydruidion Railway.

(Abandonment of Railway; Release of Deposit; Dissolution of Company; Repeal of Acts, &c.)

NOTICE is hereby given, that application is intended to be made to Parliament in the next session for leave to bring in a Bill for the following purposes, or some of them (that is to say):—

To authorise the Ruthin and Cerrigydruidion Railway Company (in this notice referred to as "the Company") to abandon the construction of the railway and works authorised by "The Ruthin and Cerrigydruidion Railway Act, 1876," and "The Ruthin and Cerrigydruidion Railway (Amendment) Act, 1881."

To provide for the release of the deposit made with the Chancery Division of the High Court of Justice in England in respect of the application to Parliament for the said "Ruthin and Cerrigydruidion Railway Act, 1876," and of any interest or dividends which have accrued or may accrue on the said deposit or any part thereof, and to relieve the Company from all further obligations for or with respect to the

non-completion of the said railway and works within the period limited by the before recited Acts.

To dissolve the Company, and to make provisions for winding-up their affairs and the discharge of their debts and liabilities, and for cancelling all contracts, bonds, and agreements of or with the Company, and for the release of the Company from all liabilities in respect of the said railway and works.

To make all provisions incidental or necessary to the purposes aforesaid, and to vary or extinguish all rights and privileges which would interfere with the objects of the Bill.

To repeal, alter, or amend all or some of the provisions of "The Ruthin and Cerrigydruidion Railway Act, 1876," and "The Ruthin and Cerrigydruidion Railway (Amendment) Act, 1881," and of any other Act relating to or affecting the Company.

Totnes, Paignton, and Torquay Direct Railway. (Abandonment of Railway; Release of Deposit; Winding-up and Dissolution of the Company, and Repeal of Act.)

NOTICE is hereby given, that the Totnes, Paignton, and Torquay Direct Railway Company (hereinafter called "the Company"), intend to apply to Parliament in the ensuing session for leave to bring in a Bill to authorise and require the abandonment of the railway and works authorised by "The Totnes, Paignton, and Torquay Direct Railway Act, 1880," and to release the Company from all liabilities, penalties, forfeitures and obligations for the non-completion thereof.

The Bill will provide for the winding-up of the affairs and the dissolution of the Company, and it will repeal or alter all or some of the provisions of "The Totnes, Paignton, and Torquay Direct Railway Act, 1880."
