Lincolnshire (Lindsey).-(1.) The whole of the parish of Newton-on-Trent, in the petty sessional division of Lincoln, in the Parts of Lindsey, Lincolnshire.

(2.) The whole of the parish of Stickford, in the petty sessional division of Spilsby, in the Parts of Lindsey, Lincolnshire.

(3.) The parish of Theddlethorpe, in the petty sessional division of Calceworth, in the Parts of Lindsey, Lincolnshire.

(4.) The parish of Gayton-le-Marsh, in the petty sessional division of Calceworth, in the Parts of Lindsey, Lincolnshire.

(5.) The parish of Saleby-with-Thoresthorpe, in the petty sessional division of Calceworth, in the Parts of Lindsey, Lincolnshire. (6.) The parish of Hannah-cum-Hagnaby, in the petty sessional division of Calceworth, in the Parts of Lindsey, Lincolnshire.

(7.) The parish of Hogsthorpe, in the petty sessional division of Calceworth, in the Parts of Lindsey, Lincolnshire.

- Soke of Peterborough.—The whole of the Soke of Peterborough, with the exception of the parishes of Pilsgate, Wittering, Ufford, Barnack, Ashton, Bainton, Southorpe, St. Martins (Stamford Baron), and Wothorpe.
- Rutland.—The whole of the parish of Tickencote, in the county of Rutland.
- Shropshire.—All that portion of the county of Salop comprised within 'the following boundaries, that is to say, the main-road from Shipley to Bridgnorth commencing at the boundary of the counties of Stafford and Salop near Shipley Common so far as Roughton, thence to the river Worfe, thence along the river Worfe to the junction with the river Severn, thence by the river Severn to Ccalport Bridge, thence to the Coalport and Wellington Branch Railway, thence by the said Railway to the Watling Strect - road near the London and North-Western Railway-station at Oakengates, and thence along the Watling-Street-road to the county boundary near Weston.
